Additional Backup Information

This contract will provide for the purchase of an estimated 25,000 tons of trap rock surface aggregates for the Street and Bridge Division. The two main materials used in seal coating are asphalt binder and cover aggregate. Trap rock is the cover aggregate. It is applied after existing pavement is sprayed with asphalt binder during Seal Coat resurfacing applications. Trap rock is also used in the same manner for maintenance and repair of various street improvement projects. Approximately 400 Lane Miles are resurfaced per year and an increase is anticipated due to the growth of the City.
