Additional Backup Information

This contract will provide delivery, installation, preventative maintenance, and repair services for two conveyORIZED X-ray screening stations and two metal detection systems at City Hall. One screening station and one metal detection system will be placed at the north entrance of City Hall, and the other one at the south entrance.

The X-ray screening equipment is designed to inspect bags, briefcases, parcels, and other containers for the presence of weapons, explosives, and other threat items. The equipment will allow for zooming capabilities for closer viewing of scanned objects. The metal detection systems contain walk-through and hand-held scanning capabilities. Both ferrous and non-ferrous metallic objects can be detected. Concealed metal weapons will be picked up as well.
