
(U) SYNOPSIS

- On October 13, 2011 at approximately 2:00am, four Occupy Austin protestors were arrested after refusing to leave the City Hall Plaza.
- e A group of protestors have been present at this location for over a week and the area has become a sanitary concern for the City. The protestors were given both written and verbal notices and warnings by the City prior to the arrests. Letters were dispersed to the crowd in the evening hours on October 12th informing the group for the need to wash down and clean the area. At 10:00pm, supervisors from the Austin Police Department addressed a crowd of approximately 75 protestors and informed them of the cleaning and the provided them direction to an alternative area across the street where they could gather until completion of the cleaning. At about 2:00am site security for City Hall requested all persons depart the location as previously requested so the cleaning could take place. All protestors complied with the request except four individuals. After not complying with repeated instructions by police to temporarily vacate the area, they were arrested.
