

Historic Landmark Commission MINUTES

REGULAR CALLED MEETING Monday, August 25, 2014

The Historic Landmark Commission convened in a special called hearing on Monday, August 25, 2014 at One Texas Center (Room 325), 505 Barton Springs Road in Austin, Texas.
