Authorize award and execution of a 36-month requirements supply agreement with LEIF JOHNSON FORD DBA TRUCK CITY FORD, consistent with the City's authority to invoke local preference in awarding contracts, to provide original equipment manufacturer parts for Ford medium and heavy-duty vehicles in an amount not to exceed \$766,212, with three 12-month extension options in a total amount not to exceed \$255,404 per extension option, for a total contract amount not to exceed \$1,532,424.

Amount and Source of Funding

Funding in the amount of \$255,404 is available in the Fiscal Year 2014-2015 Operating Budget of the Fleet Services Department. Funding for the remaining 24-months of the original contract period and extension options is contingent upon available funding in future budgets.

There is no unanticipated fiscal impact. A fiscal note is not required.

Additional Backup Information

This supply contract will provide for OEM parts for Ford medium and heavy duty vehicles. These parts will be purchased on an as needed basis to provide the Fleet Service Center Technicians with a reliable and continuous source of supply to maintain and repair City-owned vehicles. The City currently has approximately 470 Ford medium and heavy duty vehicles in the fleet inventory.

This recommendation is in accordance with Local Government Code 271.905 and Resolution number 20140807-113 to invoke local preference. The local bidder is offering the best combination of contract price and additional economic development opportunities for the City created by the contract award, including the employment of residents of the City and increased tax revenues to the City.
