#### Subject

Authorize award and execution of a 36-month requirements supply agreement with EQUIPMENT SOUTHWEST, INC. to provide aftermarket repair parts for garbage truck bodies in an amount not to exceed \$836,235, with three 12-month extension options in a total amount not to exceed \$278,745 per extension option, for a total contract amount not to exceed \$1,672,470.

## Amount and Source of Funding

Funding in the amount of \$278,745 is available in the Fiscal Year 2014-2015 Operating Budget of the Fleet Services Department. Funding for the remaining 24-months of the original contract period and extension options is contingent upon available funding in future budgets.

This contract is for the purchase of repair parts for various manufactured garbage truck bodies for City-owned refuse collection trucks that require aftermarket manufactured repair parts on an as needed basis.

The parts will be used for the daily operations of general routine repair and maintenance services for refuse trucks performed by City technicians. The City currently has approximately 115 refuse vehicles in the Fleet inventory which include various brands of truck bodies such as Heil, Labrie, Wayne, Leach, and Pak-Mor. This contract is necessary to support the Fleet Service department with a reliable and continuous source of supply to purchase these parts.
