Authorize award and execution of a 36-month requirements service agreement with PYRO ENGINEERING, INC. DBA BAY FIREWORKS for IFB-BV No. TLG0102, to provide a firework display for The City's New Year's Eve Celebration, in an amount not to exceed \$57,000 with three 12-month extension options in an amount not to exceed \$19,000 per extension option, for a total contract amount not to exceed \$114,000.

Amount and Source of Funding

Funding in the amount of \$19,000 is available in the Fiscal Year 2014-2015 Operating Budget of the Economic Development Department. Funding for the remaining 25 months of the original contract period and extension options is contingent upon available funding in future budgets.
