

## **RESOLUTION NO.**

**WHEREAS,** schools and families play a critical role maintaining strong communities, directly impacting a broad range of issues from jobs and the local economy to the environment, civic engagement and our future as a city; and

**WHEREAS,** families and children are a protected class under the Fair Housing Act; and

**WHEREAS,** Imagine Austin, the city's comprehensive planning document, specifically recognizes the need for strong public schools and family-friendly development citywide, topics that have often lacked clear focus in the past; and

**WHEREAS,** the Joint Subcommittees of the City of Austin, Austin Independent School District (AISD), and Travis County have already identified student stability as a key area of collaborative focus, and in 2013 created the School and Family Work Group to "generate policy recommendations aimed at supporting neighborhood schools and retaining families with children in the central city"; and

**WHEREAS,** the Work Group released its final report, "Retaining Families and Strengthening Schools in Central Austin" in January 2014, with the specific notation that, while its charge was limited to Central Austin, many of its

recommendations could be beneficially applied throughout the city and county;  
and

**WHEREAS**, the report identifies a number of specific policy actions for the City of Austin, AISD, Travis County Commissioners Court, and other entities such as the University of Texas and non-governmental bodies, all designed with the critical public goal of keeping our city healthy, wealthy and wise; **NOW, THEREFORE**,

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

The City Manager is directed to report back to the Council by November 15, 2014 with a timeline for the implementation of strategies to promote the development of family-friendly housing in the City based on recommendations made by the School and Family Work Group of the Joint Subcommittees of the Austin City Council, AISD Board of Trustees, and Travis County Commissioners' Court:

1. **Use CodeNEXT Project to Promote Affordable Family-Friendly Housing.** The City of Austin should identify and adopt land use policies through the current revision of the City's Land Development Code to promote a diverse range of affordable, family-friendly housing across Austin, especially in the urban core, and provide examples of what policy changes can be considered and implemented.

**2. Expand Housing Planning Efforts among Public Entities to Specifically Target Families with Children.** The City of Austin and Austin Independent School District (AISD) should partner with non-profit organizations and community members to develop strategies for closing the affordable housing gap in Austin specifically for families with children. Strategies should embrace the policy and organizational leadership and guidance of the Joint Subcommittee where expertise from the community, AISD, Travis County and the City of Austin work collaboratively to address the multiple issues impacting families with children to include:

- addressing school attendance zones with declining enrollments as identified by AISD;
- targeting programs to create more family-sized housing in those zones as well as areas of higher opportunity as appropriate,
- prioritizing housing bond funds for affordable housing for families with children;
- establishing a policy to be adopted by public entities to include the City of Austin, Travis County and AISD regarding surplus property and capital planning coordination;

- developing policies and guidelines for giving preference to families with children in family-sized affordable housing developments; and
- Identifying strategies to increase student stability utilizing existing programs such as the Family Resource Centers and Best Single Source Plus service model to target housing counseling resources, emergency rental housing assistance, and utility assistance funding specifically for low-income families with children in neighborhoods with high rates of student mobility in public schools, working in partnership with AISD to ensure refinement of goals and objectives as needed to decrease student mobility and increase family stability.

3. **Explore Partnerships for Family-Friendly Developments.** The City of Austin should create and help fund a model affordable family-friendly development in a densely populated urban area. In addition, the City of Austin and AISD should explore opportunities to partner in creating affordable family-friendly housing on surplus or underutilized government property at or near AISD schools in under-enrolled attendance zones, in areas suffering from high rates of student mobility, or areas of high opportunity according to Texas Department of Housing and Community

Affairs Housing Tax Credit (HTC) Program Qualified Allocation Plan  
scoring criteria.

4. **Enhance Safe Routes to Schools, Parks and Libraries.** By 2016, the City of Austin in coordination with AISD, other school districts, and Travis County should expand the Safe Routes to School model to provide safe pedestrian and cycling routes to schools, parks, and libraries, and target funding for the plan in the next transportation bond package.
