SECTION OF CHARTER OR ORDINANCE VIOLATED: 2-2-22 - FUNDRAISING AND BUNDLING BY INTERMEDIARIES

DATE OF ALLEGED VIOLATION: Activities Sept. 5th - Sept. 19th, 2014, reflected on Candidate's '30 Day Out' filing and Schedule ATX5 filing on Oct. 6, 2014.

ACTIONS ALLEGED TO BE A VIOLATION:

Candidate Casar did not file a Schedule ATX 5 form to disclose effective bundling for donations totaling \$5,950.00 from employees and spouses of Force Multiplier Solutions, Inc., a purveyor of security systems for school buses. Regardless of whether the bundler delivered the donations to the candidate as one; the solicitation, obtaining and dollar amount effectively meet the definition of bundling under § 2-2-22, and Candidate Casar should have erred on the side of full disclosure and transparency by informing the source of the funds and by filing Schedule ATX 5 on the bundled donations from Force Multiplier Solutions, Inc. employees and spouses.

Further, Candidate Casar willfully took responsibility for the infraction by signing the 'Form C/OH' in affirmation to the following: "I swear, or affirm, under penalty of perjury that the accompanying report is true and correct and includes all information required to be reported by me under Title 15, Election Code," and further required under § 2-2-3 - CONFORMITY WITH TEXAS ELECTION CODE, penalties to be meted out under § 2-2-5 - OFFENSES AND PENALTY.



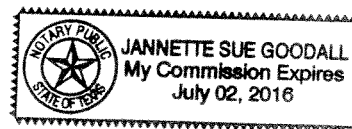

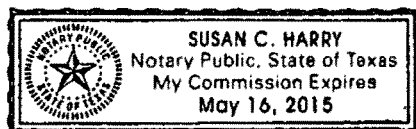
