<u>SUMMARY STAFF RECOMMENDATION</u>: Staff recommends the proposed zoning change from multi-family residence, neighborhood plan (MF-4-NP) combining district to multi-family residence – Historic Landmark – neighborhood plan (MF-4-H-NP) combining district zoning.

QUALIFICATIONS FOR LANDMARK DESIGNATION:

Architecture and Historical Associations. The house is an excellent example of an Arts & Crafts bungalow, the precursor to the Craftsman style, which dominated bungalow design in the 1920s, and represents a middle-class dwelling built, owned and occupied by a machinist for the Tips Foundry and his wife, who was a professional masseuse and treated some of Austin's most prominent citizens, including Lyndon and Lady Bird Johnson.

BASIS FOR RECOMMENDATION:

Architecture:

One-and-a- half story, rectangular-plan, front-gabled stuccoed frame bungalow with a projecting front-gabled bay to the left of the front façade; partial-width inset porch on

stuccoed plain square posts; flat arches with coved intrados; false half-timbering in the tympanum of the primary front gable; Craftsman-style front doors at right angles, both with a transom; single and paired 1:1 fenestration with 4:1 wood screens.

Historical Associations:

The house is located on property originally owned by Carl Wendlandt, who lived in the large house next door (1500 W. 9th Street, a city historic landmark). Wendlandt was a major developer in the city, and in 1910, he subdivided the parcel where this house was built. Wendlandt sold this property to Amil (or Amel or Emil) Nelson in September, 1911. Amel Nelson executed two mechanic's liens: one to R.G. Mueller, the trustee for W.S. Drake, the proprietor of Calcasieu Lumber Company, and the other to William H. Nelson, a carpenter and house contractor, in October and December, 1911 for the materials and labor for the construction of the house.

The builder, William Hardy Nelson (no relation to the property owner) was a Texas-born carpenter and house contractor. The 1909-10 and 1910-11 city directories list William H. Nelson as a carpenter, contractor, and builder. Business must have been good for William H. Nelson at the time he built this house – the 1912-13 city directory has a large, bold-print listing for him. Directories of the mid-1890s reveal that William H. Nelson had worked as a carpenter for George Fiegel (1895-96), a prominent carpenter, contractor, and builder, whose services also included building design.

Amil T. Nelson, the first owner of the property and the house, was born in Pennsylvania to Swedish-born parents. He appears in the 1900 U.S. Census as a servant for, and living in the house of Emerson Scarbrough, one of the city's leading merchants, who had a large department store (Scarbrough & Hicks, later E.M. Scarbrough & Sons, later Scarbrough's) at the corner of 6th Street and Congress Avenue. By 1902, he was working as a servant for, and living in the house of Robert L. Brown, the vice-president of City National Bank, who with his brother, J. Gordon Brown, were the proprietors of Brown Brothers, land mortgage bankers, with offices over the City National Bank at 614 Congress Avenue. Amil Nelson does not appear in the 1905 nor the 1906-07 city directories. He married Mary (or Marie) Dora (or Dorothy) Schmidt around 1906; the city directory of 1909-10 shows him as a machinist for the Walter Tips Foundry, and living at 402 E. 3rd Street, which the 1909-10 city directory and the 1910 U.S. Census confirm is the Schmidt family home. The census report shows that the household at 402 E. 3rd Street included Marie Schmidt, a widow, Amil and Marie Nelson, and Marie Schmidt's four other children: Frank Schmidt, 23, Carl Schmidt, 21, both salesmen in a cigar store; Wallie Schmidt, 19, and Marguerite Schmidt, 10, neither of whom had occupations. Amel Nelson was listed as a foundry machinist.

After living with Mary's mother and family for a few years, Amel and Mary bought this property and built this house. The 1912-13 city directory is the first to show Nelson at this address; previous directories showed him at his mother-in-law's house on E. 3rd Street. Amel Nelson's 1918 World War I draft registration card shows that he was born April 4, 1875, lived at 1502 W. 9th Street, was married to Mary D. Nelson, and was a machinist for the Tips Foundry and Machine Company. He was of medium height and medium build with brown eyes and black hair, and had "no obvious defects" as recorded on his registration card. The 1920 and 1930 U.S. Census reports show Emil and Mary Nelson as the owners of this house. Emil was a machinist at the foundry or iron works. He worked as a machinist for the Tips Engine Works through the early 1930s. Amel Nelson died in Austin at the age of 57 in January, 1933.

After Amel's death, Mary Nelson continued to live in the house until her death in 1962. She was the daughter of German-born parents who had worked as tailors and dressmakers, and Mary herself had worked as a secretary for the State Tuberculosis Unit. In her later years, she became a professional masseuse. Among her clients were Lyndon and Lady Bird Johnson.

Around 1934, Mary Nelson created an apartment in the house for herself, and rented out the main section of the house for extra income. Her tenants included a book-keeper at a cotton exporter, a high school teacher, a salesman, and an inspector for the State Highway Department. Her brother, Frank Schmidt, a packer for the Walter Tips Company, a wholesale and retail hardware business, rented the house for several years in the late 1930s, and lived with Mary from the late 1930s through Mary's death in 1962. Mary's sister, Wallie Schmidt, a typist and office secretary, also rented the apartment from the early 1950s until Mary's death. From the early 1950s through 1962, the house and apartment were occupied by Mary Nelson's family members.

After her death in 1962, her siblings sold the property to Mary Alva Barnes, a widow, and her daughter, Florenda Barnes. Mary Alva Barnes was the widow of John C. Barnes, a Tennesseeborn locksmith with his own shop. They appear in the 1930 U.S. Census as the renters of the house at 304 E. 11th Street in Austin. John C. Barnes was 59; Mary A. Barnes was 41, and had been born in Texas. She had no occupation listed. Their daughter, Florenda (noted in the census report as Bernadine), was 9. The had a roomer, Virginia Riffe, a 25-year old widow who was a waitress in a hotel. The 1940 U.S. Census shows John C. and Alva Barnes as the owners of the house at 500½ E. 10th Street in Austin, where they lived with their daughter Florenda B. Barnes. John C. Barnes was then 68, and listed as a locksmith with his own shop. Neither Alva nor Florenda Barnes had an occupation listed. Mary Alva and Florenda Barnes lived here until Mary's death in 1977 in Hays County, Texas; Florenda Barnes lived here until her death in September, 1986.

Upon Florenda Barnes' death, the house was sold to Thomas and Mary Mathey, who lived here until 2010. The Matheys renovated the first floor of the house and expanded the attic space into a master bed- and bathroom. The Matheys sold the house to the current owners.





distinctive character of the Old West Austin neighborhood.

By unanimous vote on October 6, 2014, the Steering Committee of the OWANA voted to support the historic zoning of the Mary Nelson House.

F.(9) Historical Narrative

This lot was platted in 1910 by Austin real estate mogul **Carl W. Wendlandt** as one of twelve lots in the Wendlandt subdivision(1). It was first purchased by **Amil T. Nelson (a.k.a Emil)**, soon after he began working as a machinist for Walter Tips Foundry and Machine Co. at Baylor St. and West 3rd St.(2) He paid \$750 in cash for the lot; the assessed value, according to the City Lot Register from 1909-1910, was \$1000(3).

Amil was the son of Swedish immigrants, Peter and Nellie Nelson, who owned a farm in rural Travis County(4). The 1900 Census states that Amil was a servant for **Emerson Scarborough** at 2612 Whitis Ave. In the 1903 Austin City Directory, Nelson works as a servant for **Robert L. Brown**, Vice President of City National Bank, at his residence at 2001 University Ave. Amil married his wife, **Mary Dora Schmidt**, around the same year he purchased the lot. Mary was the daughter of German immigrants Franz and Marie Schmidt(5), who owned and worked as tailor and dressmaker at the Lone Star Pants Co. at 817 Red River(6). Before marriage, Mary worked as a secretary for the State Tuberculosis Commission of the State Board of Health(7).

In 1911, Amil and Mary paid contractor **William H. Nelson** \$1250 to build a single story, frame house(8). William was an independent contractor, who had previously worked for notable architects **Henry Loughry** and **George Fiegel**(9). The house is a classic Craftsman style bungalow, built in the middle of a deep, upwards inclining lot. Later in 1911, Amil and Mary took out a loan of \$550 against the house(10).

It's unclear as to what improvements were made to the house during the period it was owned by the Nelsons. The only city permits issued for this house before 1984 were for a sewer tap in 1919, a water tap in 1935, and another sewer tap in 1942(11). However, the 1935 Sanborn Fire Map, compared to the previous Sanborn map from 1922, indicates that an addition was made to the back of the house, and two small outbuildings were erected at the back of the lot, where the alley was once accessible by car. The 1935 Sanborn map notes two addresses on the same lot (1502 and 1502 ½), but it is not clear how the two units were divided. The City Lot Register shows the assessed value of the property doubled in 1935, from \$4465 the previous year, to \$8815. Seeing as Amil passed away in 1933, it's likely the addition was made a few years prior to when the value was re-assessed by the tax appraiser.

After the passing of her husband, **Mary Nelson** began to rent out the main part of the house. She likely lived in the southwest corner of the house, where there is a separate entrance from the front porch. The 1940 Census lists Mary at 1502 ½ W. 9th St., along with her brother Frank, who was employed as a shipping clerk for a hardware store at the time. At that time the main house was rented to Carl W. Barfield and his family. This included his wife Mary, their two young sons Gilbert and Carl, and an 18 year old boarder named Hattie Daugherty. Gilbert Barfield is still living, and he recalls that Hattie was his nanny, and she also attended the University of Texas. His step-father, Carl, worked as a grocery salesman at Sears, and was later promoted to manager, relocating the family to Dallas. Gilbert and his brother attended Mathews Elementary School. He recalls they had a victory garden in the backyard, and he would ride the city bus for five cents one-way.

Mary Nelson had several siblings, nieces, and nephews who lived in Austin and visited her home often. According to her family descendants, Mary Nelson was a trained masseuse, and would treat clients in her home. Mary Nelson's nephew, Reverend Raymond Ernest Bowles of St. John's Lutheran Church in Galveston, reports that on several occasions Mary had the honor of treating Mr. and Mrs. Lyndon B. Johnson. This would have been during the time LBJ was serving as representative for Texas's 10th Congressional district, from 1937 to 1949.

Mary Nelson passed away at her home in November of 1962. Her obituary states that she was a member of the First English Lutheran Church at 3001 Whitis Avenue. She is buried next to her husband in Oakwood Cemetery, along with her parents and siblings. Mary Nelson's estate went to her siblings, who sold the house in 1963. The siblings sold the home to an elderly widow, Mary "Alva" Barnes, and her daughter, Florenda Barnes(12).

Mary Alva's husband, John C. Barnes, was a locksmith, and passed away sometime in the late 1950s (13). Both were life-long residents of Austin. Their daughter, Florenda Bernadine Barnes, served in the Women's Army Corps in World War II(14). She attended the University of Texas after the war, but her later occupation is unknown(15). Mary Alva and Florenda continued to rent out part of the house, just as Mary Nelson had done.

After Florenda passed away in 1986, the house was purchased by Thomas and Mary Mathey, who took excellent care of the home for over 20 years. The Matheys renovated the first floor, and expanded the attic space into a master bed and bath. The original architectural and design details of the home have been preserved, such as the craftsman style doors, windows and trim, the wide front porch, and gable roof. The original cast-metal, art nouveau ceiling lights remain hanging in the home.

1502 West 9th Street deserves historic landmark status because it is a well-preserved example of period architecture, is associated with a historically significant person, and its history exemplifies middle class life in Austin in the early to mid 20th century.

Historic Landmark Criteria:

(i) Architecture

Early 20th-century (ca. 1915) craftsman-style bungalow with scalloped front-gable brackets, front porch archways, exterior and interior transom windows, and stucco facade with wood banding.

(ii) Historical Associations

Private visits by US Rep Lyndon Baines Johnson and his wife Mrs. Ladybird Johnson.

(iv) Community Value

This property is listed as a contributing structure to the **West Line National Register Historic District**. The original owner, Emil T. Nelson, is mentioned in the National Register of
Historic Places Registration Form (16) made by the Old West Austin Neighborhood
Association. It is one of the early residences that give Old West Austin its distinctive
character.
