**PROPOSAL**

---

Construct a new carport, a new rooftop observation deck, a new two-story screened porch on the back of the house, re-roof the house with synthetic slate, and install a back yard pool and landscaping.

---

**PROJECT SPECIFICATIONS**

---

The house currently has a rooftop observation deck that the applicant proposes to enlarge, and connect by means of a staircase on the back of the house over a new two-story screened porch. The proposed observation deck will have a 36" tall steel guardrail and will be accessed via an exterior metal spiral staircase. The proposed two-story screened porch will have a steel structure with clear cedar trim and stops. The existing slate roof will be replaced with a synthetic slate roof. The applicant further proposes the construction of a carport with metal posts, a metal roof, and stone piers. The applicant further proposes the installation of a pool in the back yard.

**STANDARDS FOR REVIEW**

---

The house is contributing to the Old West Austin National Register Historic District, which has no specific design guidelines for additions. General design principles for historic districts encourage additions to the rear of the house with scale, massing, materials, and fenestration patterns complementing the house and other contributing houses within the district.

---

**STAFF RECOMMENDATION**

---

Recommend the removal of the existing rooftop observation deck, but recommend the construction of the new observation deck on top of the proposed rear screened porch addition or as an independent structure rather than on top of the house. The proposal for the rooftop observation deck will give the house the appearance of having a widow's walk, which is inconsistent with the style and character of the house. The other proposals for the house meet the recommended guidelines for modifications to contributing structures in historic districts.
