Additional Backup Information

This authorization provides for an additional funding which will be distributed among nine firms to allow for continuation of new assignments.

On June 23, 2011, twelve firms were selected for the 2011 Large Scale General Civil Engineering Rotation List with a total authorization amount of \$9,600,000. This rotation list was established to provide planning, preliminary engineering, design, construction, project management and other engineering services as necessary. To date, seven firms have received assignments for an estimated total of \$4,733,573.38. Three of the remaining five firms are developing proposals for an estimated total of \$700,000.

The additional \$1,444,999.97 in authorization will be provided for project continuation to the consultants in the following amounts; Jacobs Engineering Group Inc. \$194,583.33, Atkins North America Inc. \$133,333.33, Kellogg Brown & Root Services Inc. \$133,333.33, Espey Consultants Inc. \$133,333.33, MWM DesignGroup Inc. \$133,333.33,
