This contract with National Works, Inc. is for the removal of debris in Lift Station No. 2 Influent Wet Well at South Austin Regional Wastewater Treatment Plant. The debris is located at the flow line of the influent Govalle Wastewater Tunnel due to the Halloween Flood of 2013 and is approximately 10 feet deep, based upon the results of a TV inspection conducted in December 2013. All work is scheduled for completion in December 2014.

This contract is necessary to prevent clogging of the Govalle Wastewater Tunnel and the Downtown Tunnels which could result in a discharge of untreated wastewater into the Colorado River. All work is scheduled for completion within 30 calendar days after notice to proceed.
