Additional Backup Information

This contract will provide the Urban Forestry division of Parks and Recreation Department (PARD) with shade trees and seedlings for the Fall 2014 planting season. These trees will consist of large caliper inch trees for park and CIP projects and are necessary to meet the increased canopy coverage goals related to Imagine-Austin's Green Infrastructure Priority Program, and the Austin Urban Forest Plan. The seedlings are required for riparian park plantings, which are instrumental in slowing the runoff of rain water into streams and other wetlands. Trees and seedlings purchased through this contract will meet the needs of the PARD's Urban Forestry Program, Planning and Development Review's Austin Community Trees Program, and Watershed Protection's Grow Zone Program.
