Additional Backup Information

Resolution 20140828-82 directed the City Manager to seek recommendations from the Parks and Recreation Board and the Animal Advisory Commission regarding potential code amendments to allow for swimming and an off-leash area at Barton Springs Spillway. As such the Parks and Recreation Department considered the following specific City Code regulations:

City Code Section 8-5-49 A person may not swim in Barton Creek Between Town Lake and Barton Springs pool or between the western dam of Barton Springs Pool and a point 100 yards west of the dam.

City Code Section 3-4-1 Except as provided in Section 3-4-4 (Public Areas Where Restraint of a Dog is Not

Required), an owner or handler of a dog shall keep the dog under restraint.

The Watershed Protection Department and the Austin Travis County Health and Human Service Department collected water samples in July 2014 and September 2014 and compared the 2014 sampling to samples taken over the past 5 years in order to measure water quality. These Departments found bacteria levels are variable and exceed acceptable human contact standards during periods of high usage. Additionally, the sampling indicates concurrent human and dog swimming areas do not support safe fecal indicator bacteria levels.

The Parks and Recreation Department desires to support human swimming in Barton Creek in the area between Town Lake and Barton Springs pool but recommends that the City continue to enforce City Code Section 3-4-1 (Public Areas where restraint of a dog is not required) as currently written.
