Good Morning Council Members and staff,

I write **in support** of Glen and Paula Foore and Springdale Farms in their zoning application that would currently remove the restrictive covenant and remove the outdoor event zoning restriction. This zoning case would not immediately allow events as a subsequent Conditional Use Permit would be necessary to be applied for, negotiated for, reviewed by City staff, and approved.

There are several activists in the area that oppose the farm and purport to speak fully for the neighborhood and those opposed to the farm and it's continued necessary diversified operations. As a neighbor, I have attended multiple neighborhood meetings to discuss the concerns of immediate neighbors as well as the greater neighborhood and their view of the future of the Springdale tract of land.

The existing commercially zoned farm has and needs several revenue sources in order to support its business model sustainably year-round as farming alone is not sufficiently reliable (especially with the increasing taxes of the CS zoned farm). Glen and Paula host a farm stand twice a week, work the fields daily, provide jobs to neighbors, host educational events for local schools, foundations, and educational outreaches, and share their farm for rental events such as weddings. This has been ongoing for approximately two years and the events were something that was a result of local customers and those in the food community that could think of nothing better than sharing their wedding day on a local Austin farm that means so much to them and their community. This support and interest in weddings and events offered a diversified means by which to both give back to the community through education events and provide a offsetting income stream to support the immense challenges of farming which have been acute these last several years in exceptional drought conditions.

The farm is located across the street from APD's Springdale substation that supports two adjacent patrol sectors as well as investigative units. In the past two years (Nov. 5, 2012 - Nov 17, 2014) records been 341 incidents within 1000-feet of Springdale Farm as tracked by APD's incident reporting (see attached PDF). Out of those, in the neighborhood within 1,000 feet there were 7 were unreasonable sound/disturbance, 14 disputes/family disturbances, 8 public intoxications, 24 forms of assault , 1 murder and 23 thefts reported. Of those, **NONE were on Springdale farm.** Only 1 incident reported (Suspicious activity at 4pm on Jan 1st 2014) was at Springdale Farm. The existing neighborhood is a challenging place and Springdale farm is a stable and safe community force in the middle of it.

Daniel and Angelica repeatedly have incited neighbors with stories that paint the picture of scores and scores of extravagant wealthy Travis Heights and Clarksville debauchers who descend into the quiet community and drink everything in site whilst dancing and playing horrible loud music until all hours

of the night. While these stories are inconveniently not true, they have been able to be leveraged into a movement that paints rumors of Glen & Paula trying to open a 5,000 square foot restaurant or that they will start hosting large music events. These stories were put forth in order to secure (or coerce if one is of differing opinion) multiple neighbors into signing the petition that opposes the currently proposed items 145, 146, & 147.

At the first two neighborhood meetings I attended, there was about a 50/50 split on the immediate neighbors view of the farm being able to host events (purely pro/con - not limiting in number or frequency). At planning commission Glen and Paula reiterated the fact that they had attempted to meet with neighbors to discuss their concerns but that Daniel & Angelica's initial position cited that the neighbors were not willing to negotiate or compromise and that the goal was to return Springdale Farm to SF land after the farm had failed, sold, and the FLUM is enforced. This has been stated by Daniel in multiple public meetings and, to me, is the frightening underscoring purpose in several of the neighbor's activities; not that there aren't some neighbors with valid concerns over the details of hosted events (decibel levels, hours of activity, safe adjacent parking). Glen and Paula have been more than willing to negotiate such reasonable concerns; but there is no receptive figurehead to negotiate with, nor is this a productive moment to do so. The conditional use permit stage process is likely the more effective time to fully delve into the details and operations of events and hopefully the affected neighbors can be negotiated with on a one-to-one basis at that time.

This leaves Glen and Paula in an extremely problematic situation: their livelihood, home, and support structure currently reside in hostile limbo due in some part to the valiant efforts of the urban farm ordinance and also to the beyond-complicated zoning and land use codes. One of the great things about Austin is its nationally recognized local restaurants, food sustainability, and farming community which is reflected in the City's stated support of local food, urban farms, sustainability, SNAP, & local food health activities.

Those opposed to the items before you will continually note that this is not about farming, that it is about events and the 22-odd neighbors that are effected. They will classify food truck service as an event and will graciously offer to compromise at four total events a year with all on-site parking and no noise after 8 or 9pm. This is not the case. The existing commercial zoning and the farm it supports needs to have its event restriction lifted in order to survive. The future required Conditional Use Permit will be the process in which to fully negotiate and evaluate the parking, sound, and number of events. With regard to the subjective food truck classification as an event: while it may be a genuine concern and a complicated topic, this is not the case before you nor is that larger issue able to be solved in this setting.

As the end of the year draws closer, the agenda items build, and many (but not all) of your council terms draw to a close; please consider this not as merely a 'zoning' case. It is a vibrant local & neighborhood farm whose extensive community of support starts in their own neighborhood and reaches across Austin, to the families that shop at the farm stand, the school children that visit the farm on a field trips, the couple that can think of no better wedding venue, and the scores of nationally renowned locally-owned small businesses & restaurants who showcase what Austin is and what it can grow & support.

My fear is that this farm and the community that supports it goes the way of many neighborhood, community, and culturally defining sites in Austin and is eventually transformed into another high-end dense multifamily site (it is zoned CS and entitled to such development and is in the hottest growth area outside of South Austin). While I don't believe that is that intent of those activists that oppose this case, the neighborhood &

community at large, or you on council; relatively small decisions such as these are tipping points that allow the slow progression to such an outcome.

Thank you for your time, service, consideration, and patience (In reading this rambling as well as all your work sessions and council meetings that will undoubtedly go till 2a.m. or later for the remainder of the year).
