Authorize award and execution of a 36 -month requirements supply contract with YOUNGBLOOD AUTOMOTIVE & TIRE LLC to provide tires in an amount not to exceed \$1,703,478, with three 12-month extension options in an amount not to exceed \$567,826 per extension option, for a total contract amount not to exceed \$3,406,956.

Amount and Source of Funding

Funding in the amount of \$473,188 is available in the Fiscal Year 2014-2015 Operating Budget of the Fleet Services Department. Funding for the remaining 26 months of the original contract period and extension options are contingent upon available funding in future budgets.
