## ORDINANCE NO.

## AN ORDINANCE AMENDING CITY CODE CHAPTERS 9-2 (NOISE AND AMPLIFIED SOUND) AND 9-4 (PROHIBITED ACTIVITIES) RELATING TO AUDIBLE NOISES AND MUSIC AND SOLICITATION.

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. City Code Section 9-2-2 (Applicability) is amended to remove Subsection (B).

PART 2. City Code Sections 9-2-3 (General Restrictions) is amended to read as follows:

## § 9-2-3 GENERAL RESTRICTIONS.

(A) A person may not:

- (1) use or permit the use of sound equipment at a business <u>that produces</u> <u>sound</u>
  - (a) in excess of <u>85 decibels between 10:00 a.m. and 2:00 a.m., as</u> measured at the property line of the business; or
  - (b) is plainly audible at the property line of the business between 2:00 a.m. and 10:00 a.m.[the decibel limits prescribed by this chapter];
- (2) <u>use or permit the use of sound equipment at a residence that produces</u> <u>sound</u>
  - (a) in excess of 75 decibels at the boundary line of the residence; or
  - (b) <u>is plainly audible at the boundary line of the residence between</u> <u>10:00 p.m. and 10:00 a.m.;</u>
- (3) make noise or play a musical instrument <u>that is plainly</u> audible <u>from the</u> <u>boundary line of the nearest</u> [to an adjacent] business or <u>residentially</u> <u>occupied property</u> [residence]
  - (a) <u>between 1:00 a.m. and 7:00 a.m. in the following areas</u>
    - (i) 600 to 900 blocks of Red River Street;
    - (ii) Sixth Street District;

(iii) <u>Warehouse District; or</u>
(b) between 10:30 p.m. and 7:00 a.m. in all other areas of the City;
<ul> <li>(4) operate a machine that separates, gathers, grades, loads, or unloads sand, rock, or gravel within 600 feet of a residence, church, hospital, hotel, or motel between 7:00 p.m. and 6:00 a.m., except for the installation of concrete as authorized under Section 9-2-<u>21[15]</u> (<i>Permit for Concrete Installation During Non-Peak Hour Periods</i>);</li> </ul>
(5) use or authorize or allow the use of a vehicle, equipment, attachment, or device associated with a vehicle, for cold hold, refrigeration, or freezing of any consumable food or beverage product, including water in any form such as consumer ice or ice used to refrigerate food or beverage, between 7:00 p.m. and 6:00 a.m. if noise or sound originating from the vehicle or any associated equipment (such as an engine or generator, equipment, attachment, trailer or device) is audible or causes vibration at a residence;
<ul> <li>(6) operate sound equipment in a vehicle audible or causing a vibration 30 feet from the equipment, except as authorized under Section 9-2-22 (<i>Permit for Sound Equipment on Vehicle</i>); or</li> </ul>
<ul><li>(7) operate sound equipment in a watercraft audible or causing a vibration 100 feet from the equipment.</li></ul>
<b>PART 3.</b> City Code Section 9-2-4 ( <i>Restriction on Decibel Level</i> ) is repealed and replaced to read as follows:
§ 9-2-4 PERMIT REQUIRED.
A person may not use or permit the use of sound equipment that is audible to the public without a permit required by this chapter.
<b>PART 4.</b> City Code Section 9-2-5 ( <i>Restriction on Use of Sound Equipment in a Residential Area</i> ) is repealed.
<b>PART 5.</b> City Code Section 9-4-13 ( <i>Solicitation Prohibited</i> ) is amended to amend Subsection (A) to read as follows:
§ 9-4-13 SOLICIATION PROHIBITED.
(A) A person commits an offense if the person solicits:
(1) in an aggressive menner in a public area:

19 20 21 22	<b>PART 6.</b> Six months after the effective date of this ordinance, the City Manager shall report to Council on any issues related to blocked entrances and exits and abuse of amplified sound that result from this ordinance and also any recommendations to address the issues.
