**PROPOSAL**

---

Demolish a ca. 1912 house.

**ARCHITECTURE**

---

One-story, rectangular-plan, pyramidal-roofed frame house; full-width, inset porch on ornamental metal supports; single and paired 25:1 fenestration.

**RESEARCH**

---

The house appears to have been built around 1912 as a single family house. It is not clear if the house was built as a rental, but apart for a short period of ownership by the occupants in the late 1940s and early 1950s, the house has been a rental for all of its existence. It is clear that the house was attractive to middle- and upper middle-class families: the roster of tenants included the manager of a meat packing plant, the assistant manager of a lumber company who went on to establish his own lumber company in Del Rio, Texas, several state employees, an adjunct professor at the University of Texas, and the brother of Paul O. Simms, who was his partner in a very prominent real estate and insurance business in town. The house was purchased around 1946 by Alex Habeeb, the son of Lebanese immigrants who had lived in San Antonio for many years. Habeeb lived here with his widowed mother, and is credited with establishing the first discotheque in San Antonio. He and his mother lived here until the mid-1950s, when the house was then subdivided into three apartments (later four), which housed students and other folks associated with the university.

**STAFF COMMENTS**

---

The house is listed in the Comprehensive Cultural Resources Survey (1984) but without a priority for research.

**STAFF RECOMMENDATION**

---

Postpone to February 23, 2015 to enable the applicant to consider alternatives to demolition. The house is a classic example of transitional-style residential architecture (between the excesses of the late Victorian Queen Anne and the more straightforward bungalows of the 1920s), even though it seems that the front porch has been modified. While there does not appear to be sufficient historical significance to warrant individual designation as a historic landmark, this style and scale of housing is very typical of the neighborhood, and thoughtful consideration should be given to preserving it on-site and allowing other development on the property.

## **BIOGRAPHICAL NOTES**

### **Edgar F. and Bessie Measels (ca. 1915 – ca. 1918)**

The 1910 U.S. Census shows Edgar F. and Bessie Measels as boarders in the home of John Rainwater in Goldsboro, Coleman County, Texas. Edward Measels was 28, had been born in Texas, and was the manager of a lumber yard. Bessie Measels was 20, had been born in Texas, and had no occupation listed. Their landlord, John Rainwater, was listed as the proprietor of a hotel.

According to his 1918 World War I draft registration card, Edgar F. Measels had been born in 1880, and was the manager of a lumber yard in Del Rio, Texas. His wife's name was Bessie.

Edgar F. and Mary Measels appear in the 1920 U.S. Census for Del Rio, Texas, where Edgar was a lumberman with his own lumberyard. He died in Del Rio in 1959.

#### **James Anderson and Clyde D. Fitzgerald (ca. 1918 – ca. 1921)**

J. Anderson and Clyde D. Fitzgerald appear in the 1920 U.S. Census as the renters of this house. J. Anderson Fitzgerald was 36, had been born in West Virginia, and was a professor in business at the university. Clyde D. Fitzgerald was also 36, had been born in West Virginia, and had no occupation listed. They had a daughter, Mary J. Fitzgerald, 10, who had also been born in West Virginia.

#### **Walter D. and Jennie Mosteller (ca. 1931)**

Walter D. and Jennie Mosteller appear in the 1930 U.S. Census for Pilot Point, Denton County, Texas, where Mosteller was a 68-year old Georgia-born farmer. Jennie Mosteller was 54, had been born in Arkansas, and had no occupation listed. They had 2 daughters: Ruth, 17; and Alice, 15. Neither had an occupation listed.

#### **Daniel and Jane Manigault (ca. 1934 - ca. 1938)**

Daniel and Jane D. Manigault appear in the 1930 U.S. Census as the renters of the house at 119 Laurel Lane in Austin. Daniel Manigault was 64, had been born in South Carolina, and was a division engineer for the State Highway Department. Jane Manigault was 53, had been born in South Carolina, and had no occupation listed. They had a daughter, Mary Louise, 23, who had been born in Texas, and was a draftsman for a blue print company.

The 1940 U.S. Census shows D.E.H. and Jane Davis Manigault as the owners of the house at 1102 Claire Avenue in Austin. D.E.H. Manigault was a district engineer for the State Highway Department. Jane Davis Manigault had no occupation listed. Their daughter, Louise, was a teacher at the junior high school.

 D. E. H. Manigault, 87, resident of Austin for the past twenty-five years, died at his home, 1102 Claire Avenue, early Tuesday morning. He was district engineer for the State Highway Department from 1919 to 1945, when he was made special research engineer. He served in that capacity until his retirement Sept. 30, 1948.  
 Survivors are his wife, Mrs. Jane Manigault, and daughter, Miss Louise Manigault, both of Austin.  
 Funeral services will be held at All Saints Chapel, 209 West 27th Street, at 10 a.m. Wednesday with Rev. Gray M. Blandy officiating. The body will be sent to San Antonio for cremation by the Weed-Corley Funeral Home. The family has requested that flowers be omitted.


**Alex Habeeb (ca. 1946 – ca. 1954)**

Alex Habeeb appears in the 1940 U.S. Census report for San Antonio, Texas, where he and his mother, Daisy, rented a house. Alex Habeeb was 16, had been born in Texas, and had no occupation listed. Daisy Habeeb was 36, had been born in Texas, and was a maid in a school.


**Alex Habeeb**, of San Antonio, Texas, Purple Heart recipient, passed away on November 12, 2006. Alex was born in Beirut, Lebanon, July 29, 1924, son of Daisy and Nofel Habeeb, deceased. He moved to Austin, Texas, in 1931 and graduated from San Antonio High School in 1942. After graduation Alex entered the U.S. Army infantry. He made the first wave landing on Omaha Beach and sustained injuries which he recovered from in France and returned to action until the end of the war. He received four Bronze Stars for bravery and the Good Conduct medal. Alex attended the University of Texas and in 1953, moved to San Antonio, Texas, to establish the El Dorado Amusement Company and built the first discotheque. Alex was the nephew of Genevieve Habeeb and husband Henry (Sheik) Habeeb, Sr. (deceased), George Habeeb; and cousin to Hoda Nassour, Joseph E. Sab, Harvey Sab, Jr., Gary G. Habeeb, Henry A. Habeeb, Jr., Ronald W. Habeeb, Rose Marie Habeeb, Alfred Habeeb, many more aunts and cousins. Recitation of the Holy Rosary will be held at 7:00 pm on Tuesday, November 14, 2006 at Wilke-Clay-Fish Funeral Home. Mass of the Christian burial will be celebrated at 2:00 pm on Wednesday, November 15 at Wilke-Clay-Fish Chapel with Reverend George Joseph officiating. Interment will follow at Assumption Cemetery.


