Authorize award and execution of a 24-month requirements supply contract with COMMUNITY TRUCKING L.L.C. for the purchase of flexible base material for the Austin Water Utility in an amount not to exceed \$786,760 with two 12-month extension options in an amount not to exceed \$393,380 per option, for a total contract amount not to exceed \$1,573,520.

Amount and Source of Funding

Funding in the amount of \$295,035 is available in the Fiscal Year 2014 – 2015 Operating Budget of the Austin Water Utility. Funding for the remaining 15 months of the initial contract period and extension options are contingent upon available funding in future budgets.

PRICE ANALYSIS

- a. Adequate competition.
- b. 30 notices were sent, including two MBE's and there are no known WBE's for this commodity code. Five bids were received, with no response from the MBEs/WBEs.
- c. The pricing offered represents an average of 16% increase from the previous contract awarded October 2012. This can be attributed to the fluctuation in fuel and manufacturing costs.
- d. Community Trucking LLC is the current provider.
