# REGULAR MEETING WEDNESDAY, JANUARY 21, 2015

The Downtown Commission convened in a meeting on Wednesday, January 21, 2015 at 301 W. 2<sup>nd</sup> St. in Austin. Texas.

# 1. CALL TO ORDER & INTRODUCTIONS

Vice Chair Bart Whatley called the meeting to order at 5:40 p.m.

# 2. CITIZEN COMMUNICATION: GENERAL

# 3. APPROVAL OF MINUTES OF THE OCTOBER 15, 2014 AND NOVEMBER 19, 2014 MEETINGS

The minutes from the October 15, 2014 and November 19, 2014 meetings were approved on a vote of 10-0 on Commissioner Galligan's motion and Commissioner Sher's second, with Commissioners Nix and Barrera off the dais.

# 4. ELECTION OF OFFICERS (CHAIR AND VICE CHAIR)

Commissioner Joel Sher was elected Chair, on Commissioner Galligan's nomination and Commissioner Nix second, on a vote of 11-0, with Commissioner Barrera off the dais.

Commissioner Bart Whatley was elected Vice Chair, on Commissioner Mathon's nomination and Commissioner Willenzik's second, on a vote of 11-0, with Commissioner Barrera off the dais.

#### 5. BUSKING ORDINANCE

The Downtown Commission approved a motion to approve the amendments to City Code Chapters 9-2 (Noise and Amplified Sound) and 9-4 (Prohibited Activities), conditioned upon the oversight of a permitting office to be determined by the Council.

The recommendation was approved on Commissioner Galligan's motion, Commissioner Sher's second, on a vote of 9-2, with Commissioners Sokol and Mathon opposed and Commissioner Glover abstaining.

# 6. CODE AMENDMENT REGARDING AFTER HOURS CONCRETE INSTALLATION

The Commission approved a motion to postpone action, on Commissioner Glover's motion and Commissioner Metteauer's second, on a vote of 12-0.
