## PROPOSAL

Construct a second-story addition.

## **PROJECT SPECIFICATIONS**

The applicant proposes to construct a second-story addition longitudinally on the house. The proposed addition will be built between forward- and rear-facing gables on the original house, and will have a clipped side gable to lower the profile and roofline of the addition, stucco finish to match the existing house, and a composition shingle roof to match that on the existing house. The addition will have a shed dormer in the middle of the roof on the front of the house.

### STANDARDS FOR REVIEW


The Old West Austin National Register Historic District has no design guidelines for new additions. General design principles for additions to contributing houses recommend compatibility in terms of scale, massing, floor-to-height ratios, and materials.

## STAFF COMMENTS


The house is contributing to the Old West Austin National Register Historic District, and dates from around 1930. It was the long-time home of Dr. F. Banner Gregg and his wife, Isabel, who lived here for the rest of their lives. Dr. Gregg was the son of Frank C. Gregg, who with Zachary T. Scott, founded the Scott & Gregg Clinic, the precursor to the Scott & White Clinic. Banner Gregg practiced in the Scott & Gregg Clinic for many years, opened his own medical practice, then finally became the medical director at Austin State School.

### STAFF RECOMMENDATION

Approve as proposed. This is a very sensitively-designed addition that complements the character, materials, scale, and massing of the existing house.

## **BIOGRAPHICAL NOTES**

### F. Banner and Isabel Gregg (ca. 1930 - )

The 1930 U.S. Census shows Banner and Isabel H. Gregg as the owners of this house, which was worth \$10,000. Banner Gregg was 27, had been born in Texas, and was a physician in general practice. Isabel Gregg was 23, had been born in Texas, and had no occupation listed. They had 2 children: Mary M., 2; and Frank H, 6 months.

The 1940 U.S. Census shows Banner and Isabel Gregg as the owners of this house, which was worth \$7,000. Banner Gregg is listed as a physician in private practice. In addition to Mary and Frank, the Greggs had another son, Banner, Jr., 3.

The Scott and Gregg Clinic was founded by physicians Zachary T. Scott and Frank C. Gregg in Austin in 1923. The clinic specialized in the treatment of tuberculosis, as Dr. Scott's mother died of tuberculosis. The Clinic closed in 1930 due to the Depression, but reopened again in the late 1930s and F. Banner Scott, who had served as the health officer for the City of Austin in the mid-1930s, was one of the partners in the venture.


# Former health officer Gregg dead

Dr. F. Banner Gregg, former city health officer and former medical director of the Travis State School, has died. He was 78.

Gregg, a graduate of the University of Texas Medical Branch in Galveston, was an associate of the Scott and Gregg Clinic until it closed in 1941. He served as city health officer 1933 to 1938.

After retiring from private practice in 1961, Gregg was medical director of the Travis State School and later joined the medical staff of the Austin State School.

Services will be at 1 p.m. today at St. David's Episcopal Church. Burial will be in Oakwood Cemetery under direction of Weed-Corley Funeral Home.
