PROPOSAL

Relocate a ca. 1904 house to an as-yet unspecified location.

ARCHITECTURE

One-story, irregular-plan, side-gabled frame house with a full-width, shed-roofed independent porch on turned wood posts with gingerbread-style brackets; double front doors with transoms above; single 1:1 fenestration.

RESEARCH

The house appears to have been built around 1904 by Wesley and Martha Hammond. Wesley Hammond was an Iowa-born butcher, who eventually opened his own meat market with Thomas Cuneo on E. 6th Street. He and his wife, Martha, lived here until around 1915, when they built the house next door, known as 75 ½ Rainey Street. Hammond continued to own this house, however, and rented it out (his son, Robert, was the applicant for a city water service permit in 1931). The house was a rental unit for over 70 years. The tenants were generally working-class, and included carpenters, painters, a cabinetmaker, and employees of the Austin Cat and Dog Hospital. George and Alice Elsey rented the house around 1920 – he was a photographer with his own studio in the 100 block of Congress Avenue. The longest-staying tenants were Chester and Lottie Puckett, who rented the house from the late 1920s until the late 1930s. Chester Puckett was a truck driver for the City Street and Bridge Department.

STAFF COMMENTS


The house is contributing to the Rainey Street National Register Historic District, and retains a high degree of architectural integrity.

STAFF RECOMMENDATION

Release the relocation permit once the proposed location is finalized. The owner of the house lived here with her family and wants the house to remain as a family home, something that is now impossible in its current location. Staff recommends the completion of a City of Austin Documentation Package consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center, before release of the permit.

Staff would also encourage the applicant to give further thought to retaining the house on – site, even though its utility as a family home is negligible in its current location. Retaining the house on site, even if it means that it would be converted to restaurant or club use, would retain more of the historic character and context of Rainey Street, and several property owners are embracing the idea of using the existing houses for new uses; it would be commendable to retain this house on site to be a part of the preservation of the character of the district.

BIOGRAPHICAL NOTES

Wesley W. Hammond (ca. 1904 – ca. 1915)

Wesley (William W.) and Martha Hammond appear in the 1910 U.S. Census at this address. Both were 40 years old. Hammond had been born in Iowa and was a butcher. Martha Hammond had been born in Germany, and had no occupation listed. They had no children listed with them.

The 1920 U.S. Census shows W.W. and Martha Hammond as the owners of the house at 75 ½ Rainey Street. Hammond was a butcher in a market.

At this house, 75 Rainey Street, were George B. and Alice Elsey, who are shown as renters. George B. Elsey was 69, had been born in Missouri, and was a photographer in a gallery. Alice A. Elsey was 57, had been born in Indiana, and had no occupation listed. They had a daughter, Hazel, 17, who had been born in Missouri, and was a clerk in a dry goods store.

Chester R. and Lottie Puckett (ca. 1928 – ca. 1936)

Chester and Lottie Puckett appear in the 1930 U.S. Census as the renters of this house. Chester Puckett was 26, had been born in Texas, and was a truck driver for the City. Lottie Puckett was 27, had been born in Texas, and had no occupation listed. They had a 3-year old son, Raymond. The 1940 U.S. Census shows Chester and Lottie Puckett renting the house at 67 Waller Street. He was a truck driver for the City. In addition to their son, Raymond, they had a 6-year old daughter, Fay. Lottie Puckett's mother, Hattie Cooper, a 59-year old widow, also lived with them.

PUCKETT, Chester R., 73, 1311 Fairwood Road, died Thursday. Services 10:30 a.m. Saturday at Hyltin-Manor Funeral Home. Survivors: wife, Lottie Puckett, Austin; sons, Donnie Puckett, Broaddus, Raymond Puckett, Dallas, Leon Puckett, Austin, Oscar Puckett, Austin; sister, Mrs. Estelle Haff, Austin, three grandchildren, six great-grandchildren.

Dennis and Pearl Blackmore appear in the 1940 U.S. Census as the renters of this house. Dennis Blackmore was 27, had been born in Texas, and was a painter. Pearl Blackmore was 26, had been born in Texas, and had no occupation listed. They had 4 children, between the ages of 8 and 1. Dennis Blackmore died in 1945 in World War II combat in Belgium.
