PROPOSAL

Demolish a ca. 1923 house.

ARCHITECTURE

One-story, rectangular-plan, hipped-roof frame houses with a partial-width inset porch; single 1:1 fenestration.

RESEARCH

The house appears to have been built in 1923; the first owners and occupants were Alfred J. and Elizabeth Ebner, who had moved to Austin from a farm near Paige in Bastrop County. They lived on Willow Street prior to moving into this house. Alfred J. Ebner was a carpenter, who died of typhoid fever in 1928. Elizabeth Ebner continued to live in this house until her death in 1957. She worked as a “canvasser” and in the Home Hygiene Project in the late 1930s. Her daughter, Corine Ebner Mathews, a nurse, owned and occupied the house after Elizabeth’s 1957 death until around 1965, when she sold the house to Virginia Puente Moreno, who lived here until her death in 1982. Virginia Moreno was a widow for all the time she lived in this house; her late husband had been a waiter in a Mexican-food restaurant; Virginia Moreno had also worked for the WPA in the late 1930s and early 1940s as a seamstress in the WPA Sewing Room.


STAFF COMMENTS

The house is listed in the Comprehensive Cultural Resources Survey (1984) but without a priority for research.

STAFF RECOMMENDATION

The house appears to be in fair condition; staff recommends that the applicant consider rehabilitation and re-use of the house if feasible; if not, then staff recommends release of the permit upon completion of a City of Austin Documentation Package consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center.

BIOGRAPHICAL NOTES:

Alfred and Elizabeth Ebner (ca. 1923 – ca. 1957)

The 1920 U.S. Census shows Alfred and Lizzie Ebner as the renters of a farm near Paige, Bastrop County, Texas. Alfred J. Ebner was 31, had been born in Texas, and was a farmer. Lizzie Ebner was 28, had been born in Texas, and had no occupation listed. They had 2 children: Corine, 8; and Dalworth, 4 months. The 1910 U.S. Census shows Alfred and Lizzie Ebner on a farm in Bastrop County, where Alfred was listed as a farmer, and Lizzie was listed as a farm laborer on the home farm.

Alfred J. Ebner died August 13, 1928 of typhoid fever. He was a carpenter.

MRS. ELIZABETH T. EBNER

Mrs. Elizabeth T. Ebner, 66, of 2211 Canterbury Street, died in a local hospital Saturday afternoon. She was born in Bastrop County and has resided in Austin for 36 years. She is survived by one son, I. C. Ebner, Austin; one daughter, Mrs. Corine Mathews, Austin; four brothers, N. Shutz, B. H. Shutz, Will Shutz, and C. A. Shutz, all of Austin; four sisters, Mrs. W. C. Mink, Miss Mary Shutz, Mrs. A. M. Smith, and Miss Rosalee Shutz, all of Austin; and four grandchildren. Funeral services will be held at Wilke-Clay Funeral Home at 2 p.m. Monday with Father Victor Goertz officiating. Burial will be in the Oakwood Cemetery Annex.

Virginia Puente Moreno (ca. 1965 – ca. 1982)

Virginia Puente (later Moreno) appears in the 1940 U.S. Census as the 21-year old daughter of Romana Puente, a 46-year old widow who rented her house at 803 E. 10th Street in Austin. Both Romana and Virginia Puente had been born in Texas; Romana Puente had no occupation listed; Virginia Puente was a seamstress in the WPA Sewing Room. Virginia Moreno died in 1982.
