Subject

Approve an ordinance authorizing acceptance of \$91,894 in grant funds from the U.S. DEPARTMENT OF HEALTH AND HUMAN SERVICES, HEALTH RESOURCES AND SERVICES ADMINISTRATION, and amending the Fiscal Year 2014-2015 Health and Human Services Department Operating Budget Special Revenue Fund (Ordinance No. 20140908-001) to appropriate \$91,894 for the Ryan White Part A HIV Emergency Relief Grant Program and Minority AIDS Initiative that provides medical and supportive services to people with the human immunodeficiency virus.

Amount and Source of Funding

Funding in the amount of \$91,894 is available from the U.S. Department of Health and Human Services (DHHS), Health Resources and Services Administration (HRSA). The grant period is from March 1, 2014 through February 28, 2015. No City match is required.

Additional Backup Information

On December 16, 2014, the City of Austin Health and Human Services Department (HHSD) received a Notice of Grant Award from the U.S. Department of Health and Human Services for the Ryan White Part A HIV Emergency Relief Grant Program and Minority AIDS Initiative (Part A) for the period of March 1, 2014 through February 28, 2015. The current appropriation in the 2014-15 budget is \$4,487,000. The requested increase of \$91,894 represents the difference between the grant appropriation of \$4,487,000 and the grant award amount of \$4,578,894. The additional grant funds are a result of Part A grant carryover from the previous fiscal year. The Austin Transitional Grant Area plans to use the grant funds for direct HIV core and support services. Services for the additional funds will be delivered by our Part A providers: AIDS Services of Austin, Inc., Austin/Travis County Mental Health Mental Retardation C.A.R.E. Program, Community Action of Central Texas, Inc., David Powell Community Health Center, Project Transitions, Inc., Waterloo Counseling Center, Wright House

Wellness Center, as well as Communicable Disease Unit, via an intradepartmental agreement with the Disease Prevention and Health Promotion Division.

The General Fund will not be required to contribute to this grant.
