This action authorizes the negotiation and execution of an interlocal agreement between the City and the Austin						
Independent School District (AISD) for administering an unfunded Austin Promise Zone (APZ), pending designation						
by the U.S. Department of Housing and Urban Development (HUD). The proposed Promise Zone encompasses						
low-income neighborhoods in the Rundberg, St. John's, Colony Park, East Central and Dove Springs areas (see map).						
AISD is the lead applicant on the 2014 Promise Zone application, with the City, Travis County, United Way for						
Greater Austin, and the Housing Authority of the City as key implementing partners. Other partnering organizations						
include: Community Advancement Network, Manor Independent School District, Del Valle Independent School						
District, The Austin Project, Children's Optimal Health, Lutheran Social Services of the South, Child, Inc., University						
of Texas at Austin, Michael & Susan Dell Foundation and neighborhood revitalization groups including Restore						
Rundberg, Colony Park, St. John Community School Alliance, Rosewood Choice and Go Austin! Vamos Austin! (Dove Springs).

Promise Zones are a part of the Obama Administration's Ladders of Opportunity agenda, and are intended to						

revitalize high-poverty communities across the country by attracting private investment, improving affordable housing, improving educational opportunities, reducing violent crime, and assisting local leaders in navigating federal programs. Promise Zones do not receive direct funding, but benefit from technical assistance, federal staff support, and more extensive preference points for Federal grant programs. Promise Zone tax credits may be enacted by Congress in the future, allowing private businesses to receive tax incentives for hiring workers and investing in Promise Zones.

According to HUD, the "Promise Zones designation will be for a term of 10 years, and may be extended as necessary to capture the full term of availability of the Promise Zones tax incentives, pending the enactment of tax incentives by Congress". The current list of opportunities includes:

All Austin Promise Zone partners commit to: 1] participating in regular meetings of the APZ steering committee; 2] collecting and sharing data for planning, implementation and evaluation of the APZ initiative; 3] making resources available to support activities associated with day-to-day implementation of the APZ initiative; 4] developing collaborative agreements and shared governance structure to ensure consistency and continuity of the APZ initiative over time; 5] leveraging their influence with stakeholder networks and adapting policy and strategic plans to promote alignment to APZ goals.

The interlocal agreement specifically commits the City to assigning staff to act as the point of contact for inquiries, coordination and reporting of activities related to APZ Goals as follows: Economic Development Department-Goal 1 Creating Jobs and Goal 2 Economic Development; Austin Police Department-Goal 4 Reduce Serious or Violent Crime; Housing and Community Development-Goal 6 Livable Communities and Transportation.
