1. Recommend approval to award and execute a 24-month requirements supply contract with **COMMUNITY TRUCKING L.L.C.** for the purchase of flexible base material for the Austin Water Utility in an amount not to exceed \$786,760 with two 12-month extension options in an amount not to exceed \$393,380 per option, for a total contract amount not to exceed \$1,573,520.
