The meeting was called to order at 5:35pm by Commissioner Horton.

1. CITIZEN COMMUNICATION

Ms. Marva Overton of the Alliance for African American Health in Central Texas spoke to the Commission concerning creation of a task force on pedestrian safety. Ms. Overton stated that she would like to make a presentation on the task force at the Commission's December meeting.

Mr. Michael Lofton of the African American Youth Harvest Foundation spoke to the Commission concerning funding received from the City's Health & Human Services Department. Mr. Lofton stated that his organization's funding was being cut 52% which was concerning as they had exceeded all obligations of their contract with the City.

Mr. Karl Nichols of the African American Youth Harvest Foundation spoke to the Commission concerning funding cuts for their organization.

Mr. Amin Simms and Mr. Catlin Whitington presented the SXSW Platinum Badge Opportunity information stating that SXSW annually awards approximately 10 platinum badges to students. The students must complete an application and essay. There is a deadline of February 15 for the applications to be submitted, but this is usually flexible.

Ms. Byrd stated that in 2014 the District had provided tours of the District, worked with Keeling Middle School on the Discover Heritage Map, and participated in Historic Downs Field Days. For 2015 the District will look at ways to fund improvements to Downs Field, provide tours of the District, and work with Rosewood Courts on their Master Plan.
