PROPOSAL

Demolish a ca. 1904 house.

ARCHITECTURE

One-story, rectangular-plan, side-gabled frame house with a partial-width shed-roofed independent porch on plain, square, wood posts; synthetic siding; solar-screens on the single windows; one-story, rectangular-plan, side-gabled frame addition to the rear with paired 6:6 non-historic windows.

RESEARCH

The house appears to have been built around 1904; the first known occupant of the house was Oscar g. Thompson, a life insurance agent, who lived here until around 1906. Stuart Francis, the county tax assessor and collector, lived here from around 1906 to around 1909; the house was then occupied by Alvin and Annie Thomson, who lived here until around 1919. Alvin Thomson was a blacksmith with a shop at 506 Trinity Street; according to his obituary, he was later associated with the University of Texas as a blacksmith.

Albert E. and Lula Alexander are listed as the owners and occupants of the house from around 1919 to around 1928, and are the first African-Americans to inhabit the house. Albert Alexander grew up on a farm in Travis County; while he and Lula lived in this house, he was a driver for Swift & Company, meat packers. The house was then a rental property until the 1990s. Tenants of the house were African-American, and included a yardman, an elevator operator, a maid, a drapery installer, a cook, and a baker.

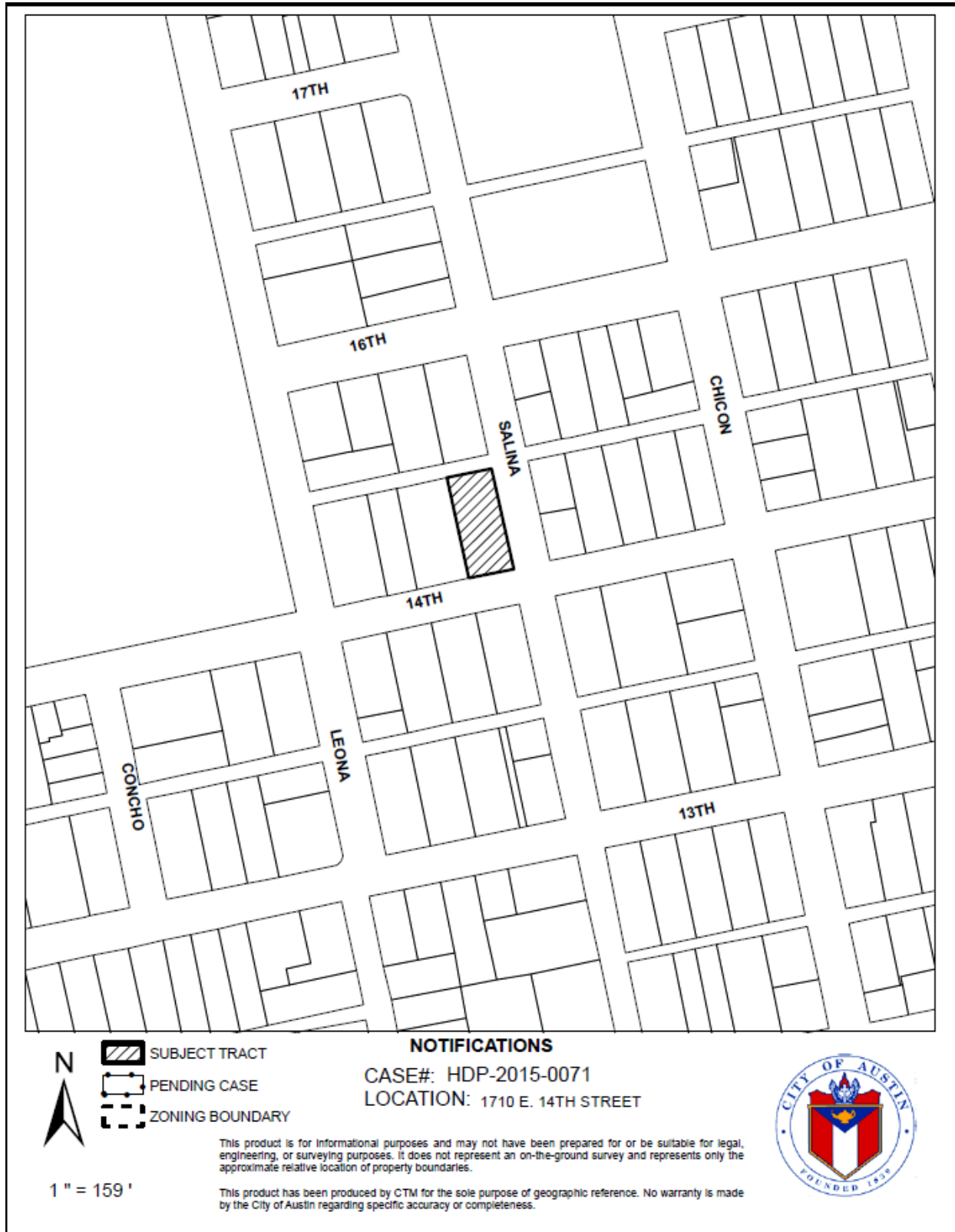
STAFF COMMENTS

The house does not appear in any City survey.

STAFF RECOMMENDATION

Encourage rehabilitation and re-use if feasible; while the house does not appear to qualify as a historic landmark, it does represent the history and architecture of the neighborhood, and alternatives to demolition should be carefully considered. If rehabilitation is not feasible, then staff recommends release of the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center.

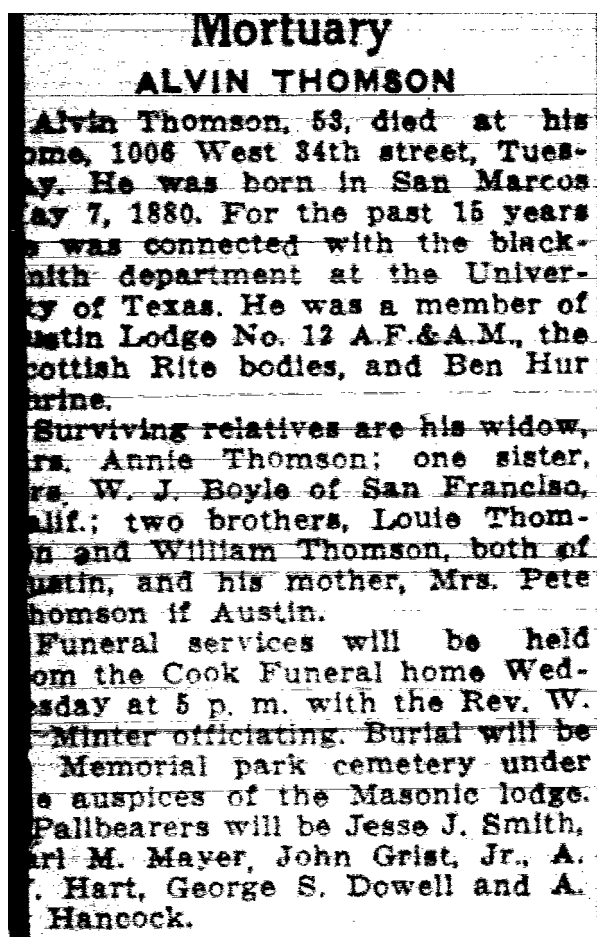
BIOGRAPHICAL NOTES

Stuart and Virgie Francis (ca. 1906 – ca. 1910)

Stuart and Virgie Francis appear in the 1910 U.S. Census at 709 Henderson Street in Austin. Stuart Francis was 42, was born in Louisiana, and has an indecipherable occupation. Virgie Francis was 34, had been born in Louisiana, and had no occupation listed. They had 2 sons: Judson, 10; and Stuart, Jr., 7, both of whom had been born in Texas. Next door to them lived James and Ruby Francis; James Francis appears to have been Stuart's younger brother; he was a Louisiana-born electrician.

Alvin and Annie Thomson (ca. 1910 – ca. 1919)

Alvin and Annie Thomson appear in the 1910 U.S. Census at this house (addressed at 1608 E. 14th Street). Alvin Thomson was 30, had been born in Texas, and was a blacksmith with his own shop. Annie Thomson was 29, had been born in Illinois, and had no occupation listed. They had no children listed with them. The 1920 U.S. Census shows Alvin and Annie Thomson as the owners of the house at 1006 W. 34th Street. Alvin Thomson was a blacksmith; Annie had no occupation listed.

Albert and Lula Alexander (ca. 1919 – ca. 1928)

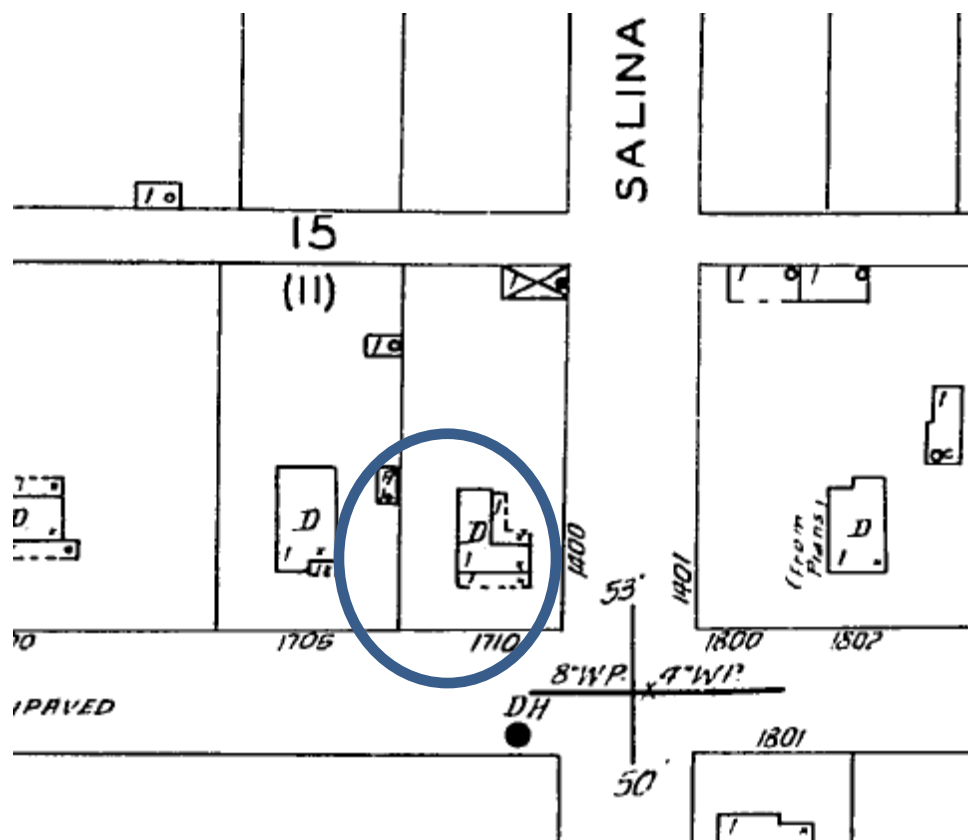
The 1920 U.S. Census shows Albert E. and Lula Alexander as the owners of this house. Both were classified as mulatto in the census report. Albert E. Alexander was 32, had been born in Texas, and was a teamster for a packing company. Lula Alexander was 30, had been born in Texas to South Carolina-born parents, and had no occupation listed. They had 2 daughters: Louise, 5; and Mozelle, 2. Both girls were born in Texas.

The 1910 U.S. Census shows Albert Alexander as the brother-in-law of Anthony and Maggie Alexander, who rented a farm in Travis County. Albert Alexander is listed as a farm laborer.

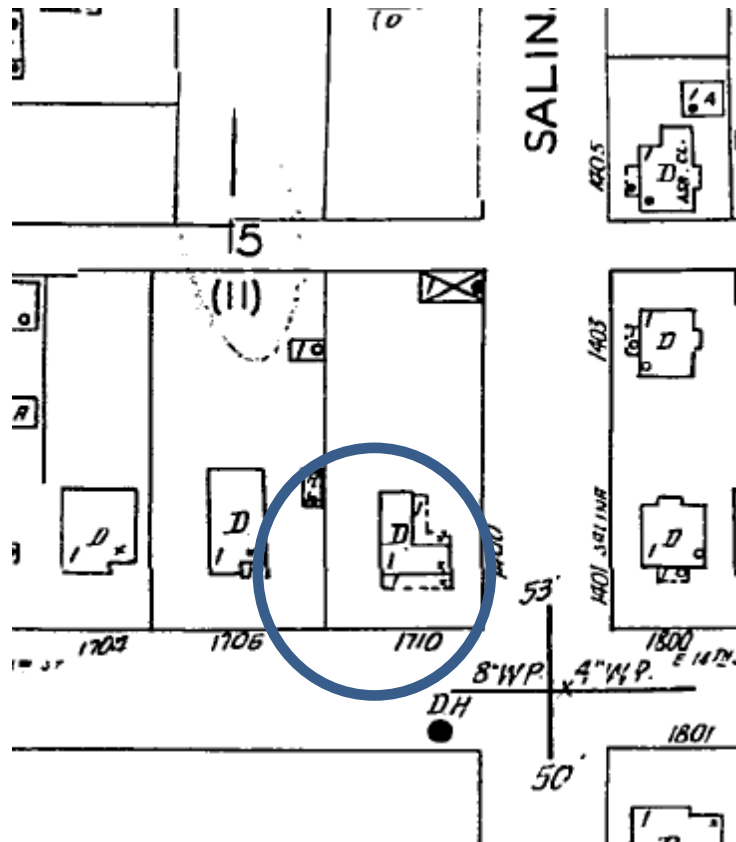
The 1900 U.S. Census shows Albert Alexander as the 12-year old son of Moses and Alice Alexander, who owned a farm in Travis County. Moses Alexander was listed as farmer; Albert was listed as a home farm laborer.

Robert and Lena Van Zandt (ca 1930 – ca. 1936)

Robert and Lena Van Zandt appear in the 1940 U.S. Census in the home of their son, Fred Van Zandt, at 1189 Comal Street in Austin. Robert Van Zandt was 80, had been born in Texas, and had no occupation listed. Lena Van Zandt was 60, had been born in Texas, and was a laundress at home. Their son, Fred, was a 42-year old widower with 2 daughters. He was a construction laborer. The 1930 U.S. Census shows Bob and Lena VanZandt as the owners of the house at 1801 Chicon Street, which was worth \$2,000. Bob Van Zandt was 70, and did odd jobs for a private family. Lena Van Zandt, 50, was a maid for a private family. Their son, James, a 33-year old widower, was a laborer in building construction. Their son, Fred, 29, was also a widower, and was a yardman for a private family. The 1920 U.S. Census shows Robert H. and Lena VanZandt on a farm in Travis County, which they rented. Robert Van Zandt was a farmer on a general farm; Lena had no occupation listed. They had children: daughter Jessie, 29; son Ben, 27, a laborer on the home farm; and daughter Telonella, 20.



The 1935 Sanborn map shows the house with a full-width front porch, a wraparound back porch, and an addition only to the west side of the structure.
