- Commissioner Gilbert reported that the Urban Transportation Commission has been having ongoing conversations about Uber. The Urban Transportation Commission received an update of the 2014 accomplishments of the Austin Transportation Commission.
- Commissioner Glover reported that the Parks Commission was aware that the Council
 was looking into Downtown parks and that Council had signed a contract with APF on
 the design build of Republic Square Park and with DAA on the maintenance plan. The
 Parks Commission is also waiting on additional information on the Seaholm Intake
 Structure Plan and continues monitoring Council's idea of placing a Carousel somewhere
 in Downtown.
- Commissioner Sokol reported that the Music Commission learned that the City cut off all applications for SXSW.
- Commissioner Willenzik reported that the Arts Commission had an overture for the Music Commission for a joint meeting to discuss future joint meetings between commissions. The Commission is also working with Richard Troxel's request to place a homeless statue somewhere in downtown.
