PROPOSAL

Demolish a ca. 1950 house.

ARCHITECTURE

One-story, wing-and-gable plan, stone-veneered frame house with a partial-width inset porch on plain, round, wood posts; single and paired 6:6 fenestration.

RESEARCH


The house appears to have been built around 1950, although there are no building or utility permits for this address, as it was outside the city limit when it was built. The first owners and occupants were Edward J. and Erna Wilson, who lived here the rest of their lives. Edward J. Wilson had previously lived on Rural Route 5 (as shown in the 1952 city directory), which corresponds to the location of this house. The street and address first appear in the city directory of 1955. Edward J. Wilson was an X-ray technician at Brackenridge Hospital. After his death in 1975, Erna Wilson continued to live in the house for several years. In the early 1990s, it was additional space for Pharmaco Dynamics, a drug-testing research center.

STAFF COMMENTS

The house is beyond the bounds of any City survey.

STAFF RECOMMENDATION

Encourage rehabilitation and re-use if feasible; the house is a classic post-World War II minimal traditional house that appears to be in sound condition. While it does not qualify as an individual landmark, careful consideration should be given to retaining the house and incorporating it into any new development on the site. If the Commission votes to release the permit, then staff recommends completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center, prior to release of the permit.
