PROPOSAL

Demolish a ca. 1949 house.

ARCHITECTURE

One-story, rectangular-plan, side-gabled frame house with a central, front-gabled entry porch; single and paired 6:6 fenestration.

RESEARCH


The house appears to have been built around 1949, although there are no building or utility records for this address, as it was outside the city limits when it was constructed. The first owners and occupants of the house were Maurice T. and Frances Bradshaw, who lived here for the rest of their lives. Maurice T. Bradshaw worked for the Gulf Oil Company until his retirement in 1973. Frances Bradshaw worked in the public schools.

STAFF COMMENTS

The house is beyond the bounds of any City survey.

STAFF RECOMMENDATION

Encourage rehabilitation and re-use if feasible. This house, like the one next door at 4006 Banister Lane, represents the character of this neighborhood for many years, and were both post-World War II minimal traditional-style houses built on large lots. While this house does not qualify as an individual landmark, it should be retained if at all possible, as its architecture and history helps define the character of this neighborhood to a high degree. If the Commission votes to release the permit, then staff recommends completion of a City of Austin documentation package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center prior to release of the permit.

M.T. Bradshaw, age 93, of Austin, Texas, passed away on Saturday, February 28, 2004. M.T. was born in Austin, Texas, on February 27, 1911, to Annie Belle McAngus and George C. Bradshaw.
