**1. APPROVAL OF MINUTES**

**2. CITIZEN COMMUNICATION: GENERAL**

Heyden Walker, Urban Planner: Travel demand management in the CAMPO plan; concerned there is no funding to deal with travel demand management; applauds City for efforts toward travel demand management.

John Laycock, AURA: Believes City of Austin is making a major contribution to the CAMPO plan, but feels the City should make substantive changes to the CAMPO plan before providing support.

Joseph Iley: Wants background checks on TNC drives.

Michael Elder ceded time to Hannah Riddering, Taxi Driver: Concerned taxi drivers have to pay ad valorem taxes and TNC drivers do not have to pay ad valorem tax.

Susan Engleking: Proposed a market approach to transit: “Tiny Transit” consisting of a mini grid.

3. Consider and develop recommendations relating to proposed amendments to City Code Chapter 13-2 to revise requirements for taxi services.

4. Consider and develop recommendations relating to the renewal of the taxicab franchises for Austin Cab I, Incorporated d.b.a. Austin Cab, the Greater Austin Transportation Company, d.b.a. Yellow Dab Company, and the Lone Star Cab Company

Discussed timeline and proposed council readings, consequences of letting franchise agreements expire; franchise expectations, specifically focused on accessibility and green fleets; extension options; franchise recommendations; possible state regulations for TNCs;

Michael Elder: Discussed dispatch concerns and his recommendations for improvements.

Joseph Iley: Favors extending agreements for a year; concerned about accessibility.

Ed Kargbo: Favors reporting requirements; offered up taxi data and to meet with committee members.

Hannah Riddering: Feels “The Formula” works, though it may need to be tweaked, concerned about dispatch acceptance; supports green vehicle incentives;

Brad Ryker: Concerned over the loss of taxicab drivers to TNCs;

Helwoza Lovitz: Believes the taxicab industry needs to improve and welcomes accessibility improvements

Syed Pervatr, ceded time to David Passmore: Requested committee take time to make decision.

Joan Khabele: Wants an increase in taxicab permits.
