- 1) Travis County, Land Water Transportation Plan update
 - 1) Questions: Executive Summaries will be available by June

 - 3) Executive Summary and growth guidance document are most important for board to look at
 - 4) Relationship between the plan and the conservation easements bond: county passed around \$22 million for conservation easements in the bond program. Hasn't been used much to date and one of the action items in the plan is to work more closely with National Resource Conservation Services. One of the main ways for county to implement is through bond programs in unincorporated areas of Travis County (50% landmass wise of the county).
