PROPOSAL

Demolish a ca. 1929 house.

ARCHITECTURE

One-story, rectangular-plan, side-gabled frame bungalow with a partial-width, front-gabled independent porch on square wood posts; single and paired 1:1 fenestration; Craftsman-style entry door; synthetic siding.

RESEARCH

The house was built in 1929. The first owners and occupants were Edwin P. and Gertrude Schulze, who lived here until around 1932. Edwin P. Schulze was a native of the Wendish community of Serbin, in Lee County, Texas. He grew up on a farm, and while living in Austin, worked as a truck driver for a bakery, the manager of a bakery and café, and a salesman. The house was a rental unit until around 1946, when it was purchased by cabinetmaker William C. Baker, and his wife, Evelyn, who lived here until around 1948.

Frank and Alice Mosteller purchased the house around 1948 and lived here for the rest of their lives. Frank Mosteller was a salesman, for the Fuller Brush Company, a door-to-door sales outfit that sold brushes and other cleaning supplies, and later for Electrolux vacuums.

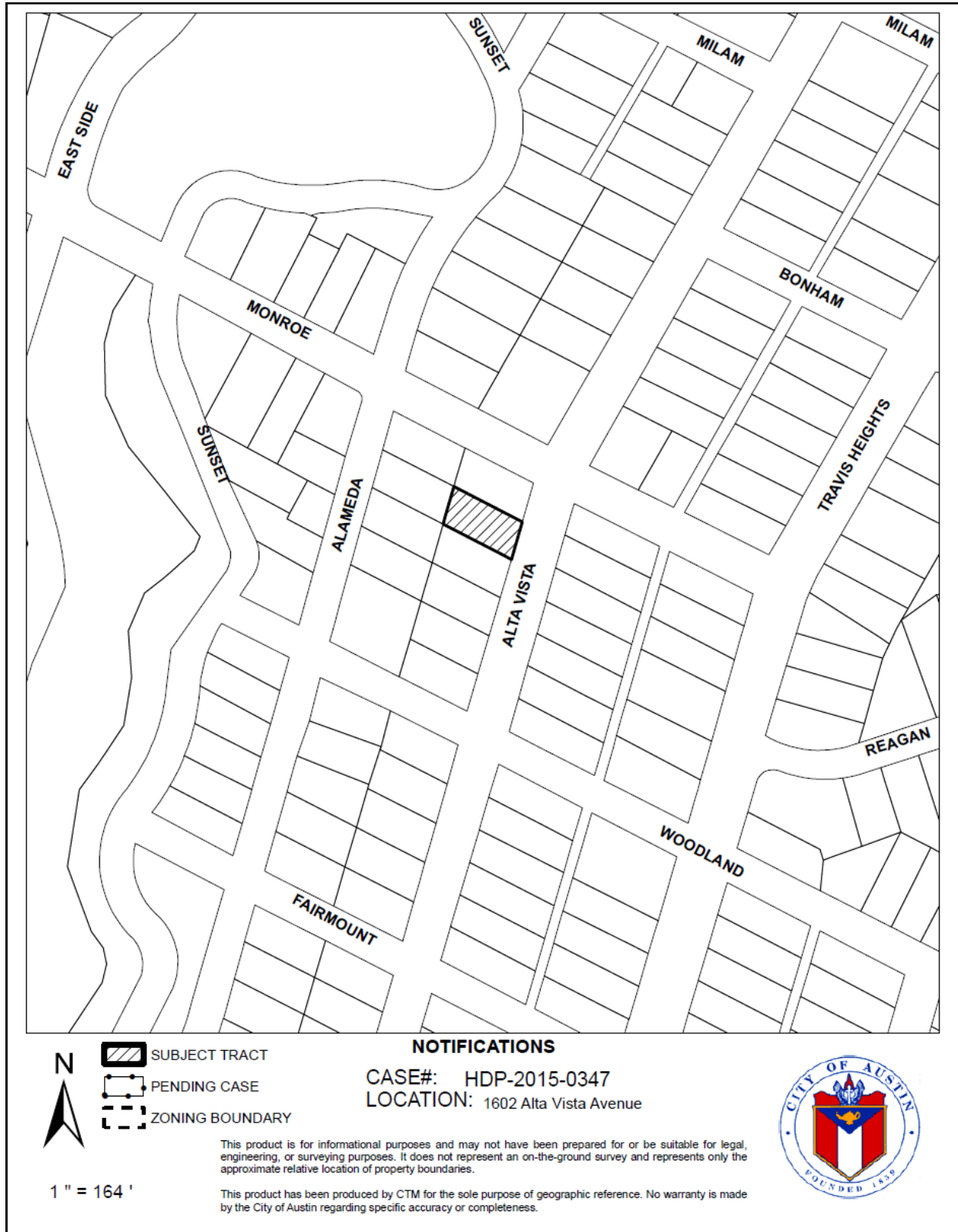
STAFF COMMENTS

The house is beyond the bounds of any City survey.

STAFF RECOMMENDATION

Postpone to June 22, 2015 to develop alternatives to demolition. While the house lacks the significant history to warrant individual landmark designation, it is a 1920s bungalow that typifies that period of development in Travis Heights, and every effort should be made to retain the house.

BIOGRAPHICAL NOTES

Edwin and Gertrude Schulze (ca. 1929 – ca. 1931)

Edwin P. and Gertrude Schulze appear in the 1930 U.S. Census as the owners of this house, which was worth \$5,000. Edwin Schulze was 25, had been born in Texas to German-born

parents, and was a truck driver for a bakery. Gertrude Schulze was 18, had been born in Texas, and had no occupation listed. They had no children listed with them.

The 1910 U.S. Census shows Edwin Schulze as the 4-year old son of Herman and Magdalena Schulze of Serbin, Lee County, Texas. Herman and Magdalena Schulze were both German Wendish, and had immigrated to the United States in 1875; Herman was a farmer. The family included 6 children.

SCHULZE—Edward P. Schulze, 32, died at a local hospital Wednesday at 3 a. m. He is survived by his wife, Mrs. Gertrude Schulze; two children, Rena Lee and Norman Ed Schulze; two sisters, Mrs. Selma Schatte of Walberg, Texas, and Mrs. Hermina Schultz of Servin, Texas; three brothers, Alvin and Bill Schulze of Servin, and Herbert Schulze of Giddings. Funeral services will be held from the Cook Funeral home Thursday at 9 a. m., at the home of his brother, Herbert Schulze, in Giddings at 1 p. m., and at the Servin Concordia Lutheran church at Servin at 2 p. m., with the Rev. K. G. Manz officiating. Interment will be in Servin cemetery.

George F. and Eva Marie Martin (ca. 1940 – ca. 1943)

George F. and Eva Marie Martin appear as the renters of this house in the 1940 U.S. Census. George F. Martin was 33, had been born in Missouri, and was a directory representative for the telephone company. Eva Marie Martin was 26, had been born in Kansas, and had no occupation listed. They had 2 children: James B. Martin, 2, who had been born in Missouri; and Sharon Marie Martin, 9 months, who had been born in Kansas. The family had lived in Kansas City in 1935.

Frank B. and Alice W. Mosteller (ca. 1948 – ca. 2000)

Frank B. and Alice Mosteller appear in the 1940 U.S. Census as the renters of the house at 1909 S. Congress Avenue. Frank Mosteller was 24, had been born in Texas, and was a

salesman for a retail feed store. Alice Mosteller was 21, had been born in Texas, and had no occupation listed. She had lived in Coleman, Texas in 1935. They had no children listed with them. The 1930 U.S. Census shows Frank B. Mosteller as the 15-year old son of Charles L. and Rosa M. Mosteller, who owned their home at 102 [East] Johanna Street in Austin. Frank had no occupation listed. His father was the proprietor of a grocery store; his mother was the manager of the grocery store.

Frank Bledsoe Mosteller

Frank Bledsoe Mosteller, of Austin passed away Tuesday, January 4, 2000 at the age of 84 years.

He is survived by his wife, Alice Mosteller of Austin; daughters, Alice Nell Wright of Austin and Anita Jane Atwood of Marble Falls, Texas; son, Raymond Dee Mosteller and wife, Sandy, of Temple City, California; sister, Mabel Lane of Austin; and five grandchildren; and three greatgrandchildren.

He was preceded in death by six brothers and sisters.
