PROPOSAL

Add a second story to the existing building and changes to the front façade.

The property is a contributing building within the Old West Austin National Register Historic District.

ARCHITECTURE

The existing building is a one story frame house with an attached garage. There is a small cross gable and the entrance is recessed from the façade line.

PROJECT SPECIFICATIONS

The proposed project is to add a second story addition with a cross gable form and make façade changes to the building by adding a partial width front porch. The building will be resided in lap-siding and new two-over two windows will be installed throughout. It is a frame building with lap siding and a cross gable form. The pediments are simple pediments with a vertical oriented siding.


STANDARDS FOR REVIEW

The house is a contributing to the Old West Austin National Register Historic District, which has no specific design guidelines for additions. General design principles for historic districts encourage additions to the rear of the house with scale, massing, materials, and fenestration patterns complementing the house and other contributing houses within the district.

STAFF RECOMMENDATION

Approve as proposed. The applicant has worked with staff to include staffs comments and recommendations. While staff encourages new additions to be added to the rear of the house and to keep the historic façade as intact as possible, the design of this building is respectful of the architecture and patterns of the district as a whole.
