

# EARLY CHILDHOOD COUNCIL MINUTES

# REGULAR MEETING Wednesday, April 8, 2015

The Early Childhood Council convened in a regular meeting on Wednesday, April 8, 2015, at City Hall in Austin, Texas.

Board Members in Attendance: Kyle Holder (Chair), Jacquie Porter (Vice-Chair), Larry Elsner, Aletha Huston, Laura Koenig, Anurita Mittra, Rhonda Paver, and Brook Son. Staff in Attendance: Health and Human Services Department (HHSD) staff – Ron Hubbard.

Chair Holder called the Board Meeting to order at 9:03 a.m.

- 1. INTRODUCTIONS: Members of the audience introduced themselves to the Council members.
- 2. DISCLOSURE OF CONFLICT OF INTEREST: None

- 4. APPROVAL OF MINUTES: The March 11, 2014, regular meeting Minutes were approved on Council Member Koenig's motion, Vice-Chair Porter's second on a 7-0 vote with Council Member Mittra arriving after the vote.

Council Member Huston made a suggestion to reach out to Chief Acevedo since many police departments have expressed support of early childhood as a crime prevention strategy.
