- 2. Commodity Crosswalk Initiative: Continued to monitor the development of the crosswalk initiative with Public Works to ensure opportunities for MBE/WBE's
- 3. Small Business Construction Program: reviewed monthly reports of program activity
- 4. Third Party Resolution: monitored agreements; facilitated presentations by Third Party Agreement participants; and made recommendations on the implementation of the resolution and associated processes. Assisted in the creation of the 3rd party handbook
- 5. SMBR Budget: received updates on department budget and made recommendations as appropriate.
