Authorize award and execution of a 36-month contract with LONGHORN INTERNATIONAL TRUCKS LTD to provide original equipment manufacturer parts and repair services for vehicles in an amount not to exceed \$627,174, with three 12-month extension options in an amount not to exceed \$209,058 per extension option, for a total contract amount not to exceed \$1,254,348.

Amount and Source of Funding

Funding in the amount of \$69,686 is available in the Fiscal Year 2014-2015 Operating Budget of the Fleet Services Department. Funding for the remaining 32-months of the original contract period and extension options are contingent upon available funding in future budgets.

Additional Backup Information

The contract is for the supply of repair parts and services of Crane Carrier manufactured trucks. Parts will be used by Fleet Service Technicians for preventative maintenance and repairs of Crane Carrier manufactured trucks. The contract will also provide repair services utilized to supplement the repairs performed by Fleet Service Technicians at the Fleet Service Center.

Currently there are 109 Crane Carrier cab chassis vehicles. The current contract will be out of authorization within the next four months. Without a contract for these parts and services, the City will be unable to repair its Crane Carrier fleet including garbage trucks, recycling trucks, and street sweepers. This will impact weekly trash pickup and other related services for City residents.
