A motion for the CDC to make recommendations pertaining to geographic area representation was made by Commissioner Mueller, seconded by Commissioner Perry, and was approved unanimously. The approved recommendations are as follows:

- o The CDC recommends that the existing seats for East Austin and Rosewood-Zaragosa Blackland be retained;*
- o that a seat be added for the North Austin area; and*
- o that the boundaries for the South Austin seat be adjusted to encompass Oltorf Street to the North, East Ben White Blvd to the South, South IH 35 to the East, and Manchaca Road to the West.*



A motion to approve the proposed 2015 Community Needs Assessment Plan was made by Commissioner Mueller, seconded by Commissioner Amin, and approved unanimously.
