REGULAR MEETING

The Urban Renewal Board convened in a regular called meeting on Monday, May 18, 2015 at the Street-Jones Building, 1000 East 11th Street in Austin, Texas.

An Urban Renewal Plan's primary purpose is to eliminate slum and blighting influence within a designated area of the city.
