

**ORDINANCE NO. 20150618-068**

**AN ORDINANCE AMENDING CITY CODE SECTION 12-4-64(D) TO ADD A 20 MILES PER HOUR SCHOOL ZONE ON A SEGMENT OF VARGAS ROAD FOR THE SAFETY OF STUDENTS ATTENDING ALLAN IDEA PUBLIC SCHOOL AND TO PROVIDE FOR EMERGENCY PASSAGE.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

**PART 1.** City Code Section 12-4-64(D) (*Table of Speed Limits*) is amended to read as follows:

Vargas Road from Cruz Street to 325 feet south of Santos Street. (20 mph school zone for the safety of students attending Allan Idea Public School)

**PART 2.** The amendments made in this ordinance are based on the results of a traffic engineering investigation, or "speed study," attached as Exhibit "A".

**PART 3.** The amendments made in this ordinance shall be incorporated in alphabetical order and the existing entries reordered accordingly.

**PART 4.** Council finds that school will soon be in session, and the need for a school zone at this site constitutes an emergency. Because of this emergency, this ordinance takes effect immediately on its passage for the immediate preservation of the public peace, health and safety.



**Proximity of the School Crossing to the School**

The proposed school crossing on Vargas Road is located approximately 1100 feet north of East Riverside Drive and 325 feet south of Santos Street in front of the new Allan Idea Public School. School property abuts the east side of Vargas Road between East Riverside Drive and Santos Street. There are approximately 370 students enrolled for the 2014-2015 school year and the school anticipates an enrollment of over 1000 students for the 2015-2016 school year.

**Presence of Adult Crossing Guard or Student Safety Patrol**

The City's Child Safety Program has committed an adult crossing guard at this crossing if a school zone is established. A teacher currently works this crossing during the school peaks.

**Crash History**

Austin Police Department's crash database was culled for crashes near the study intersection between August 2013 and May 2015. Four crashes were found at the intersection of Vargas Road and Santos Street.

**Sight Distance**

Approximately 800 feet of unobstructed views are provided looking north and south on Vargas Road from the location of the proposed crosswalk.

**Sidewalks**

Sidewalks exist along both sides of Vargas Road for the entirety of the street from Riverside Drive to Santos Street with the exception of an approximate 320 segment just north of Riverside Drive on the west side of Vargas Road.

**Other**

The Allan Idea Public School is a new school location on Vargas Road. The proposed school zone would allow all pedestrians north and south of East Riverside Drive to cross at a single location in front of the school with the assistance of an adult crossing guard. ATD is working with the Safe Routes to School Program to install ADA-compliant pedestrian ramps and a crosswalk on Vargas Road. School officials have committed to educating the students and parents on the best routes to school and safe crossing locations.

**Recommendation**

Based on the analysis of this information, it is my engineering judgment that a Reduced Speed School Zone of 20 mph when flashing on Vargas Road should be installed from Cruz Street to 300 feet south of Santos Street.
