

**ORDINANCE NO. 20150806-038**

**AN ORDINANCE AMENDING CITY CODE SECTION 12-4-64(D) TO ESTABLISH A MAXIMUM SPEED LIMIT OF 40 MILES PER HOUR ON A SEGMENT OF STAKED PLAINS DRIVE.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

**PART 1.** City Code Section 12-4-64(D) (*Table of Speed Limits*) is amended to add:

Staked Plains Drive from Lakeline Boulevard to Avery Ranch Boulevard.  
(40 MPH).

**PART 2.** The amendments made in this ordinance are based on the results of a traffic engineering investigation, or "speed study," attached as Exhibit "A".

**PART 3.** The amendments made in this ordinance shall be incorporated in alphabetical order and the existing entries reordered accordingly.

**PART 4.** This ordinance takes effect on August 17, 2015.



**Location:** Staked Plains Drive – Lakeline Boulevard to Avery Ranch Boulevard

Date(s) of Previous Investigation: N/A

A Traffic Engineering Investigation has been conducted by the Traffic Engineering Division to determine the posted speed limit on Staked Plains Drive from Lakeline Boulevard to Avery Ranch Boulevard in accordance with the Texas Procedures for Establishing Speed Zones, 2006 (See Figure 1).

**General Conditions:**

Staked Plains Drive functions as a four-lane divided collector street from Lakeline Boulevard to Avery Ranch Boulevard. There are sidewalks on both sides of Staked Plains Drive. Development along Staked Plains Drive is majority residential with no homes fronting the roadway. Entry to the residential areas is currently accessible by six residential streets.

**Speed / Volume Data Collected:**

Speed and volume data were collected in June 2015 to determine the appropriate posted speed limit for the study segment.



### Recommendation

The analysis of the speed data indicates that the 85<sup>th</sup> percentile speed along Staked Plains Drive is between 41.2 and 45.2 mph in the section from Lakeline Boulevard to Avery Ranch Boulevard.

Due to the functionality of Staked Plains Drive as a collector street with residential development, a speed limit greater than 40 mph is not recommended.


Based on the analysis of this information, it is my engineering judgment that the speed limit on Staked Plains Drive from Lakeline Boulevard to Avery Ranch Boulevard should be 40 miles per hour.
