Additional Backup Information

This action requests that City Council conduct a public hearing to hear public comments on the water, wastewater, and reclaimed rate changes proposed in the Utility's Proposed Fiscal Year 2015-2016 Budget. Council is scheduled to adopt the budget on September 8, 9, and 10, 2015. The City Code in Section 2-5-45 specifically requires a public hearing prior to the City Council approving any changes in electric, water, wastewater, and garbage collection rates.
