

**RENEWAL TO AND AMENDMENT OF
THE INTERLOCAL COOPERATION AGREEMENT
BETWEEN THE CITY OF AUSTIN AND TRAVIS COUNTY FOR
JUVENILE CASE MANAGEMENT SERVICES**

This Renewal to and Amendment of the "Interlocal Cooperation Agreement Between the City of Austin and Travis County for Juvenile Case Management Services" ("2015 Renewal") is entered into by and between the City of Austin, a Texas home rule municipal corporation (City) and Travis County, a political subdivision of the State of Texas (County).

RECITALS

City and County, referred to below as the Parties, entered into the Agreement for an Initial Term that began January 1, 2013, and terminated on September 30, 2013 ("Agreement").

Pursuant to the terms of the Agreement, the Agreement was automatically renewed for an additional one-year term effective October 1, 2013, and continuing through September 30, 2014 ("2014 Renewal Term").

The Agreement allows the Parties to amend the Agreement in writing.

The Parties wish to renew the Agreement for an additional one-year term, and to make certain amendments to the Agreement.

NOW, THEREFORE, in consideration of the mutual benefits to be received, the Parties agree as follows:

1.0 2015 RENEWAL TERM

1.1 Agreement Term. The parties agree to amend Section 3.0, "Agreement Term," by adding the following:

3.3 Additional Renewal Term(s). The Parties agree that, unless sooner terminated pursuant to the terms of the Agreement, and upon approval of funding by the Commissioners Court and City Council during their respective budget process relating to any Renewal Term, this Agreement may be renewed in writing by the Parties for additional one-year terms (or for such period as designated in writing by the Parties). Any such renewal shall be under the same terms and conditions as those applicable to the Initial Term unless and until the Agreement is amended in writing pursuant to Section 4.0 of the Agreement.

1.2 2015 Renewal Term. The Parties agree to renew the Agreement for an additional one-year term beginning on October 1, 2014, and continuing through September 30, 2015 ("2015 Renewal Term").

2.0 AGREEMENT FUNDS

2.1 Initial/2014 Renewal Term. The Parties agree that, pursuant to Section 6.2 of the Agreement, the amount provided by the City for the Initial Term and the 2014 Renewal Term was a total not-to-exceed amount of One Hundred and Fifty Thousand Dollars (\$150,000.00).

2.2 2015 Renewal Term Funds. The Parties agree to amend Section 6.0, "City Responsibilities," by adding the following:

6.3 2015 Renewal Term Amount. The amount to be provided by City for the 2015 Renewal Term will be an amount not to exceed Ninety-Eight Thousand Four Hundred and Fifty-Four Dollars (\$98,454.00).

3.0 INCORPORATION

3.1 City and County hereby incorporate this 2015 Renewal into the Agreement, and ratify all terms and conditions of the Agreement that are not amended above. City and County agree that the Agreement, as amended above, constitutes the entire agreement between the Parties with regard to juvenile case management services, and supersedes any prior understanding or written or oral agreements or representations between the Parties.

5.0 EFFECTIVE DATE

5.1 The Parties agree that this 2015 Renewal shall be effective on October 1, 2014, following signature by an authorized representative of each Party.
