4 **AN ORDINANCE AUTHORIZING THE CITY MANAGER TO RELEASE**
5 **TRAVIS COUNTY WATER CONTROL AND IMPROVEMENT DISTRICT NO.**
6 **17 FROM COLLECTING WASTEWATER IMPACT FEES FOR 17**
7 **RESIDENTIAL PROPERTIES DISCONNECTING FROM THE TRAVIS VISTA**
8 **WATER AND SEWER SUPPLY CORPORATION.**

10 **PART 1. FINDINGS.**
11

12 **The City Council finds that:**
13

- 14 (1) the Travis Vista Water and Sewer Supply Corporation (“Travis Vista WSC”)
15 currently operates under a grandfathered permit allowing it discharge its treated
16 wastewater effluent to Lake Travis;
17 (2) the City promotes clean water and the reduction of any source that might degrade
18 the quality of the City’s drinking water supply;
19 (3) owners of 17 residential lots currently receiving their wastewater service from
20 Travis Vista WSC are in the process of switching their wastewater service provider
21 to Travis County Water Control and Improvement District No. 17 (“WCID No.
22 17”);
23 (4) WCID No. 17 receives wholesale wastewater service from the City under a
24 contract that requires the WCID to collect from its new customers and remit to the
25 City wastewater impact fees to pay for City capital improvements or facilities
26 necessary to provide the service;
27 (5) to encourage the owners of 17 lots currently served by the Travis Vista WSC to
28 switch over to WCID No. 17 and thereby reduce the amount of treated effluent
29 going into Lake Travis, it is in the City’s interest to waive the obligation of WCID
30 No. 17 to collect and remit the City’s wastewater impact fee from the lots
31 switching wastewater service providers from Travis Vista WSC to WCID No. 17.

33 **PART 2. RELEASE FROM WASTEWATER IMPACT FEE.**
34

35 The City Council authorizes the city manager to release Travis County WCID No. 17
36 from the obligation to collect and remit wastewater impact fees attributable to the
37 following listed 17 properties, provided that within 12 months of the effective date of this
38 ordinance (i) the property has connected its wastewater service lateral to the collection
39 system of WCID No. 17, (ii) the property has disconnected from the collection system of
40 Travis Vista WSC, and (iii) Travis Vista WSC has proportionately reduced its treated
41 effluent discharge volumes into Lake Travis:
