RE: Amended Ethics Complaint against City Council Member Don Zimmerman

Pursuant to section 2-7-41 of the Austin City Code of Ordinances, this is an official complaint against Austin City Council Member Don Zimmerman for comments that he made on Facebook, and as reported in the Austin American Statesman. Council Member Zimmerman, in a public form followed by myself and other residents of the City of Austin, referred to gay individuals as pedophiles. This public statement is a violation of the City of Austin Ethics Code.

Specifically, Zimmerman violated the City of Austin's Ordinance 2-7-1(A), when he referred to gays as pedophiles during a social media commentary. Councilman Zimmerman's remarks were not impartial and irresponsible to the people of the City of Austin. Moreover, under this Ordinance, Councilman Zimmerman violated his duty to have public confidence in the integrity of its government. Councilman Zimmerman, by failing to conduct himself in a professional and ethical manner and for treating members of the public without respect and dignity, has unjustly and with impunity, labeled Austin's LGBT community as pedophiles; a claim that he cannot substantiate. The comments made by the Council Member, was a clear statement that was unprofessional and abusive.

The second ethics complaint alleged is that Council Member Zimmerman used City of Austin resources to make his disparaging remarks, in violation of Austin City Ordinance 2-7-62(J). By using either a city computer or city paid cell phone, Zimmerman violated the Standard of Conduct that he, as a Council Member, is required to uphold. "No City official or employee shall use City facilities, personnel, equipment or supplies for private purposes, except to the extent such are lawfully available to the public." Council Member Zimmerman violated this section of the Standard of Conduct in using city computers and or cell phones to make comments on Facebook, to embarrass himself, the City, and to make disparaging remarks about a segment of Austin residents that is not reflective of the City's values, and of the City's population as a whole.

Due to the lack of sensitivity of Zimmerman, and this being his second ethics review is less than six (6) months, there is a heightened concern as to whether he can represent the City of Austin in a manner that does not bring negative publicity and shame on the members of the community. I respectfully ask that a full investigation take place into this matter and that any and all sanctions be taken against Council Member Zimmerman for the egregious conduct that he has instilled upon our City.

In accordance with the City of Austin Ethics Code, I respectfully ask that Council Member Zimmerman be presented a copy of this complaint, along with the city attorney and the Ethic Commission. Moreover, I respectfully ask that a full and complete public preliminary hearing be made on this complaint within 20 working days.




