

M/WBE Summary

Public notice was given for the solicitation documents for CLMC545 Nelray Boulevard and Evans Avenue Utility Rehabilitation through the City's Vendor Connection web portal which resulted in 13 contractors receiving notification. Six contractors obtained the bid documents and six bids were received and opened on July 30, 2015. Four of the six firms were certified. M.A. SMITH CONTRACTING CO. INC. submitted the lowest responsive bid of six bids received:
