Authorize negotiation and execution of a 38 month lease extension agreement for approximately 14,327 square feet of office space for the Public Works Department, located at 105 West Riverside Drive, Suites 100, 200, 205, 210, and 220, from BY WELL I, LTD., in an amount not to exceed \$925,380.52 (District 9).

Amount and Source of Funding

Funding in the amount of \$23,017.40 is available in the Fiscal Year 2014-2015 Approved Operating Budget of the Public Works Department. Funding in the amount of \$283,804.52 is available in the Fiscal Year 2015-2016 Approved Operating Budget of the Public Works Department. Funding for the remaining contract period is contingent upon available funding in future budgets.

Additional Backup Information

The request for negotiation and execution of a lease extension for approximately 14,327 square feet of office space at 105 West Riverside Drive is a component of the space planning strategy of One Texas Center. The space is currently occupied by the Systems and Information Management Division, Construction Services, and Quality Management Divisions of the Public Works Department. The Human Resources Office, Quality and Standards Management Divisions and the Safety Office of the Public Works Department will be moving into the space that is currently occupied by Contract Management Department. Contract Management staff will consolidate at One Texas Center.

The proposed extension will amend, combine, and extend the entirety of the following lease agreements, as detailed below, for their combined 14,327 square feet, for a period commencing September 1, 2015, and expiring October 31, 2018. The lease rate includes all operating expenses such as property taxes, insurance, utilities, janitorial expenses, repairs, and maintenance. The proposed rent schedule as follows:

The lease extension rate is within the market rate per a rent study conducted by a third-party appraiser. This lease extension has been reviewed and approved by the Strategic Facility Governance Team.
