Authorize execution of a 36-month contract with BRAZOS VALLEY HYDROSEEDING LLC to provide hydromulch services in an amount not to exceed \$1,671,231, with three 12-month extension options in an amount not to exceed \$557,077 per extension option, for a total contract amount not to exceed \$3,342,462.				
Amount and Source of Funding				
Funding in the amount of \$532,077 is available in the Fiscal Year 2015-2016 Operating Budget of the Watershed Protection Department. Funding in the amount of \$25,000 is available in the Fiscal Year 2015-2016 Operating Budget of the Parks & Recreation Department. Funding for the remaining 24- months of the original contract period and extension options are contingent upon available funding in future budgets.

MBE / WBE:	This contract will be awarded in compliance with City Code Chapter 2-9C Minority Owned and Women Owned Business Enterprise Procurement Program. No subcontracting opportunities were identified; therefore, no goals were established for this solicitation.			

Additional Backup Information

The contract will provide for hydromulch services for the revegetating of creek and water quality pond sites. The primary purpose of revegetation is to control erosion that would occur in areas disturbed by maintenance work under a City general development permit.

Hydromulching is a quick method to generate vegetation and minimize erosion by spreading a mixture of seed, fiber and water over large areas. Hydromulch can be applied with various grass seed mixes that conform to the requirements of the defined area.

The contract expired September 24, 2015. Without the use of hydromulch services at sites that have been disturbed, the City will not meet the Environmental Criteria Manual standards and would be in violation of the Texas/National Pollutant Discharge Elimination System program.
